



Non-Profit Food/Beverage Vendor Agreement

This agreement made and entered into this, the _____ day of _____, 2019,

by and between the _____
(party of the first part) and the WEIMAR AREA CHAMBER OF COMMERCE, INC. DBA as GEDENKE! 2019, of the City of Weimar, State of Texas, party of the second part.

1. The party of the first part shall provide suitable food/beverage concession in the City of Weimar, State of Texas, commencing Friday and Saturday, May 10th and 11th in the Jackson Square/City Park area. Booth setup may be any time after 2 pm on Friday, up until 9:30 a.m. on Saturday. Booths must be taken down, after closing, after midnight, at the end of the festival. All vehicles must be unloaded and off the grounds by 4:30 pm Friday and by 9:30 a.m. Sat. **No vehicles will be allowed on festival grounds during the business hours of the festival.**
2. The party of the first part will have exclusivity for food/beverage products that will be sold. First Party will post their prices at their booth. Tokens will not be taken for food this year.
3. Food/Beverages Booths shall remain open until 15 minutes after the nightly entertainment concludes.
4. Party of the first part will keep their area clean of all trash at all times. Trash and all refuse must be kept in closed sealed containers. There will be no spilling of water, grease or any other substance on the street. ANY DAMAGE OR CLEANUP IS THE RESPONSIBILITY OF THE PARTY OF THE FIRST PART.
5. If a 110-electrical outlet is required, advanced notice of at least 48 hours is required.
6. Party of the first part will MAIL a check to Gedenke at PO Box 90, within two weeks after event. This check shall be based on 10% of GROSS sales not NET.
7. Cash can be accepted in all the booths. *Tokens will only be used for beer sales.*

8. Provider agrees to hold the Gedenke, the Weimar Area Chamber of Commerce, and its Directors and affiliates harmless from any claim of any nature arising from operations of the Provider at this event including loss, injury, or damages.
9. The obligations of both parties will not be affected or reduced by weather.
10. This agreement should be received at the Chamber office by April 29th, 2019 to reserve your spot and things you are selling. After that date, others will be offered to sell.
