Slattery again presented the benefits of this mower to the council. McLeroy asked if park grant money can be used to purchase this mower. Chester said he is concerned about spending money and asked if a trailer will need to be purchased. Slattery said yes. Littleton presented he trusts the recommendation of Slattery. Chester asked if possible to use grant funds and directed staff to look in to possibility.
