EXHIBIT HALL RULES AND REGULATIONS

By signing the Booth Application & Contract on reverse side, exhibitor agrees to indemnify and hold harmless the City of Nevada, Missouri and Nevada/Vernon County Chamber of Commerce, it's officers, directors, agents, and employees from any and all liabilities of every nature which may be asserted against them or any of them for any accident, condition, happening, or event, that occurs as a result of any participation at any City of Nevada event or exhibition.

OVER THE COUNTER SALES: Collection of applicable state sales tax is the responsibility of the Exhibitor making the sale. Sales of Firearms is prohibited.

FIREARMS DEACTIVATION: Breech-loading firearms displayed must be deactivated by removal of the firing pin or otherwise altered so that they may not be fired.

LIABILITY AND INSURANCE: The City of Nevada, Missouri and Nevada/Vernon County Chamber of Commerce, the building management or any officers, directors, or staff members of the same will not be responsible for the safety of property of the exhibitors, their agents or employees from theft, damage by fire, accident or other causes. Exhibitors wishing to insure their goods must do so at their own expense.

BOOTH ASSIGNMENT: The Expo Management reserves the right to make changes in booth assignments to ensure an even flow of attendee traffic or to maintain the character of the show.

COMPLIANCE WITH FEDERAL, STATE, AND LOCAL LAWS: The exhibitors must agree to comply with all federal, state, county and local fire, police, health or public safety laws, regulations or ordinances which are or may be applicable to the exhibit covered by this agreement.
