Responsibilities of the Area Committee

- Too many to list here... but here are the highlights:
 - Identification of pre-planned joint response efforts
 - Identification of appropriate procedures to mitigate incident
 - Identification of endangered / threatened species
 - Identification of hazardous substances in the port (which could be used for WMDs)
 - Integration of Marine Firefighting Plans
 - Integration of Places of Refuge Guidance
