## Sic Transit Gloria Emigrant1

The organization was established and officially registered in Norway in 2010, with the main purpose of combating the tax on Source tax, which affects emigrated senior citizens, harassing them hard and unfairly.

In spite of a high activity of meetings in the Storting, meetings with the Storting's Control and Constitution Committee, and attempts at communication with key politicians, we have not received any concern for our requirements and wishes. In recent years, no politicians answered our countless inquiries. Neither the prime minister, finance minister or others have reacted and the Ministry of Finance has decided, without objections, that the Source tax has come to stay. Politicians are not interested in the matter. "In spite of countless inquiries, no party has expressed an interest in putting the Source tax on the agenda, except when there has been an election campaign.

A new chairman was elected at the annual meeting of November 11, 2018. He proposed a new course and strategy for our business, which unfortunately the rest of the board could not support. He therefore chose to withdraw and the old board was seated.

A unanimous board in Emigrant 1 decided at the board meeting on 18.11.2018 that the organization close the business. Notification of closure has been sent to the Company Registry in Brønnøysund.

With our best will, we can not understand why politicians want to keep this tax as a punishment for the emigration of Norwegian retirees. (Only a few politicians have looked into the matter and most people feel they do not understand what it's all about). We, as ex-patriot pensioners, are not any burden to the Norwegian state. In accordance with NAV and Statistics Norway, we are currently about. 49,000 Senior Citizens residing abroad. We save the motherland about kr.4.4 billion a year in health and social expenses.

Those who pay Source tax, from the first crown, also have no rights or tax deductions in Norway, which is a serious discrimination. The Source tax amounts to only a few hundred million in revenue for the state; - an insignificant sum in the state budget, and insignificant compared to the billions wasted in aid to buy luxury aircraft for corrupt heads of state and so- called preservation of rainforests, etc. We have considered legal action against the government, but have been advised not to initiate such a process. - Firstly, it has been suggested that it could cost around \$. 3 million to bring the matter up to the Supreme Court. (and it's money we do not have).

Secondly, it has been suggested that the Norwegian judiciary is politically and permeated by corruption. (The appointment of Supreme Court judges was transferred from Justisdept to the Dommere Appointment Council in 2002. The Supreme Court Judge is still appointed by Justisdept. - As a candidate for the Supreme Court, you will certainly not get far in expressing disagreement with the government's guidelines). Most E1 members have served for quite a few years and we have run out of ideas on how to run the race. Banging our heads against the bureaucracy jungle has given us a headache and we have also approached several retirees for relief and assistance. -

But without receiving any interest. There are many "out there" with good and relevant education and insight into the issue. We have had only around 40 registered members, but no-one has expressed willingness to participate in the fight against the Source tax, other than individual posts on Face Book. "The Face Book page will be retained so far, but it will not result in any constructive progress.

The Board regrets this decision, but without response and dialogue with our politicians, the Board does not see any point in continuing the fight against the Source tax. "The members of the board are also not getting any younger as the years go by.

If anyone feels the call to continue the struggle, we will be able to contribute with relevant copies of old correspondence etc.

The Board has chosen to donate the balance cash holding of 35,000 kr to Kids Action for Kids, (www.kidsactionforkids.org), which is making a fantastic effort for children in Thailand and Myanmar.

## EDITOR:

This was Not the retirement I had envisaged when I planned my retirement prior to departure from Norway in 2003 when I believed I could trust the agreements made by the Norwegian government regarding the predictability of their promises.

The Norwegian governments «ot.prp.nr 20 (2008-2009)» makes the following statement regarding the introduction of the «source tax»: Ref. Royal Norwegian Government website: <http://www.regjeringen.no/en/dep/fin/dok/regpubl/otprp/2008-2009/otprp-nr-20-2008-2009-.html?id=539072>

«The proposal will ensure that the Norwegian tax base shall not being unreasonable reduced. Furthermore, the proposal shall prevent tax adjustments in connection with the internationalization of the labor market,private pension savings and pension recipients choice of domicile.»

The above statements are clearly in conflict with the right to free choice of domicile without discrimination. (Ref. Protocol No. 4 article 2)

On leaving Norway, I received a letter from Contract Office, which said that I was exempt from paying taxes to Norway. After having lived in Brazil for 8 years, I'm suddenly delayed 15% tax, I consider this to be a breach of contract under the International Law on ALTERATION, requiring reimbursement of all taxes paid since 2010.

The Norwegian Constitution §97 also states that no new laws may have retroactive effect.

It also violates the ECHR Act on Freedom Cross-border Transit for Emigrants Without Claims on Their Property. (Pension is not income but is considered as property.)
