It is The Registry of Aruba's (IASO) policy to verify the end-use and end-users for all aircraft registered in Aruba that are either manufactured in the United States or contain United States content. This is to ensure compliance with applicable United States export control laws and regulations, specifically Parts 736 and 744 of the Export Administration Regulations ("EAR"), as well as with the laws and regulations of the selling country and any embargoes in place by the United Nations or the country of manufacture of the aircraft, unless authorized by the U.S. Government or the country of manufacturer.

Because the aircraft you are registering with the Department of Civil Aviation of Aruba is either manufactured in the United States or contains United States content, and will be exported and used outside of the United States and/or the selling country, please confirm the following:

1. We, the undersigned Company or representative, understand that the aircraft(s) being registered is/are governed by the EAR administered by the U.S. Department of Commerce ("Commerce"), by the U.S. Foreign Assets Control Regulations ("OFAC") administered by the U.S. Department of Treasury ("Treasury"), and by the International Traffic in Arms Regulations ("ITAR") administered by the U.S. Department of State ("State").
2. We have read, understood and/or sought the advice of knowledgeable counsel regarding the meaning of "Aircraft on temporary sojourn" as defined in 15 CFR 740.15 (see Appendix) and will ensure that all aircraft operations are consistent with the applicable requirements.
3. The obligations and requirements described in Statement of Compliance shall survive the expiration or termination of any agreement or contract between us and applies to the Individual or Company listed above which includes all subsidiaries and affiliated companies.
4. We further confirm compliance with the International Money Laundering Abatement and Anti-terrorist Act, its regulations and guidelines.

The information provided herein is ***Private and Confidential*** and for the sole use of The Registry of Aruba, the Department of Civil Aviation of Aruba and other governmental agencies. It shall not in any way, be disclosed or made public to any unauthorized third party without the express written consent of the undersigned, unless requested by the law.
