

Pavement Maintenance & Reconstruction's 2025 Top Contractor Award

Pavement Maintenance & Reconstruction's Top Contractor award spotlights the annual top contractors in the **pavement, sealcoating, striping, and pavement repair** markets.

The following survey of paving and pavement maintenance contractors allows us to develop an objective and verifiable listing in each of these five industry segments.

To do that, we need to know:

- Gross Sales Volume for your fiscal year (FY) 2024 (regardless of the date that fiscal year ended).
- A breakdown by percentage of the type of work that generated those 2024 sales.
- Third-party verification of that sales total (see additional explanation at the end of the survey).

To determine whether a company qualifies for one (or more) of the five lists, we will multiply your total 2024 sales dollars by the percentage of work done in each industry segment. For example, if a contractor reports \$1 million in 2024 sales and generated 40% of those sales from paving, the number used to determine qualification for the Paving Top Contractor List would be \$400,000 (\$1 million x 40%).

Note: No sales figures will be reported or published; sales figures are only used internally for determining each list. Also, no contractor will be eligible for the list without third-party verification of your FY 2024 Gross Sales Volume.

What is the overall timeframe?

Entries due: Friday, March 28, 2025 at 11:59 PM CST

The criteria includes:

- *Pavement Maintenance & Reconstruction's* 2025 Top Contractor award winners are specific to the pavement, sealcoating, striping and pavement repair markets.
- Winners are based on sales revenue breakdowns provided by contractors in the submission process and verified by third party.
- U.S. companies only; international companies not eligible.
- Applications are free; there is no charge/fee to apply.
- Application must be completed in full to be considered. Incomplete submissions will be disqualified.
- Information will publish as listed in the nomination form. Not all pieces of the nomination form will publish. *Pavement Maintenance & Reconstruction* will not be held responsible for publishing information that was incorrectly submitted in the nomination process.
- All applications must be submitted electronically. Applications submitted via email or other platforms will not be eligible.
- Information provided in the application may be used in print and online.
- Limit one application per company. Multiple applications are not eligible.
- Contractors must self-nominate and submit their financial documents that verify total gross sales.
- PR companies, suppliers, vendors, etc. are not eligible to submit nominations.

- Honorees are vetted by *Pavement Maintenance & Reconstruction's* editorial staff.
- Winners ARE NOT determined based on relationship or advertising position with *Pavement Maintenance & Reconstruction*.
- Nominations close Friday, March 28, 2025 at 11:59 p.m. CST. *Pavement Maintenance & Reconstruction* **will not** accept any past due submissions.

To qualify and be considered for this Top Contractor award, third-party verification of your FY 2024 Total Gross Sales is required from your company's CPA, an independent CPA, your accounting firm, or a copy of the appropriate page from your tax return.

Verification must be on the CPA or accounting firm letterhead (no photocopies) and must include a statement to the effect that **"I have reviewed the company's Top Contractor application, and the FY 2024 gross sales response to question Number 7 is accurate to the best of my knowledge."**

The letter must be signed and dated and include the person's name, title and telephone number. **No financial information will be revealed;** it will be used only internally to determine qualification for each listing.
