

2025 Top Tech Startup Award

Nominations are open for Food Logistics' and Supply & Demand Chain Executive's 2025 Top Tech Startup Award, which highlights top software- and technology-based startups in the supply chain and logistics industry.

What is the overall timeframe?

Submissions open: Monday, Sept. 15, 2025

Entries due: Friday, Nov. 7, 2025

Featured on FoodLogistics.com and SDCExec.com

The criteria includes:

- Startup must be in the supply chain and logistics space and/or have customers within the supply chain/logistics landscape.
- Company must have launched a viable product in order to be eligible.
- Company must have real customers; those with only potential orders are not eligible.
- Startup must be revenue generating. \$10-50 million in annual revenue preferred, but not mandatory.
- Winning submissions are based on the ability to outline in detail the ins and outs of the startup and what it's doing to improve the supply chain space.
- Winners ARE NOT determined based on relationship or advertising position with *Food Logistics* and *Supply & Demand Chain Executive*.
- Winners will be considered for further special promotional opportunities at [Manifest Las Vegas 2026](#). Manifest will choose three of the Top Tech Startup winners to be featured on the Manifest Innovation Stage and have the opportunity to present an 8-minute demo. In addition, the three winners will be featured in The 'Fest, Manifest's weekly newsletter, as well as on the Manifest LinkedIn channel. Please note, *Food Logistics* and *Supply & Demand Chain Executive* have no bearing on the Manifest selections.
- Companies can be located nationwide and/or international.
- There is a \$99 submission fee associated with this award. The application fee INCLUDES access to the logo license should you win, which gives unlimited rights

and full access to include, share and embed the award logo anywhere, everywhere at all times. Payment is required upon completion of nomination. [CLICK HERE to submit payment](#). Those applications not accompanied by a submission payment will be disqualified.

- Be sure to hit “Submit” at the end of the application process. Application must be completed in full to be considered. Incomplete submissions will be disqualified.
- Names, titles and other information will publish as listed in the nomination form. Not all pieces of the nomination form will publish. *Food Logistics* and *Supply & Demand Chain Executive* will not be held responsible for publishing information that was incorrectly submitted in the nomination process.
- All applications must be submitted electronically. Applications submitted via email or through social media channels will not be considered.
- Information provided in the application may be used in print and online.
- Limit up to one nomination per company. Multiple submissions for the same company may result in elimination.
- Companies can self-nominate. Nominations can also come from suppliers, vendors, customers, co-workers, PR/marketing firms and/or the companies themselves. PR/marketing firms/agencies are not eligible to apply for themselves.
- Honorees are vetted by *Food Logistics’* and *Supply & Demand Chain Executive’s* editorial staff.
- Previous wins do not automatically guarantee a spot in this year’s award. Multiple applications for the same company could result in elimination. Awards from other publications/organizations also do not guarantee a win.
