

Certification of the results of the General Election held on November 5, 1996 by the State Board of Elections at the Canvass

We, the undersigned members of the State Board of Elections of North Carolina, do hereby certify that on Tuesday, the 26th day of November 1996, met in the office of the State Board of Elections at 133 Fayetteville Street Mall in Raleigh, North Carolina, where we examined, compiled and tabulated the returns transmitted to the State Board of Elections by the County Boards of Elections of the votes cast in the General Election held on November 5, 1996, by the Democratic, Republican, Libertarian, Natural Law and Reform Parties as well as unaffiliated candidates and write-in candidates for election for Presidential Electors, for United States Senator, for Member of U. S.
