Instructions (08 NCAC 03.0101)

Any voter desiring to bring charges of a violation of the North Carolina Administrative Code or of Chapter 163 of the North Carolina General Statutes with the State Board of Elections against a member of any county board of elections may do so by filing with the Board a written statement, signed and sworn under oath or affirmation of the voter. The statement must contain:

- 1) the name, residence address, and county of the member against whom the charges are brought;
- 2) a statement of the facts constituting the violation alleged, with a reference to the date and place of such misconduct; and
- 3) the names and addresses of persons who have knowledge or information of the matters referred to in the charges as filed.



It is noted that NC General Statute para 163A-796, paragraph two, states that 'Individual expressions of opinion, support, or opposition not intended for general public distribution shall not be deemed a violation of this part.' Thus, any reasonable person would conclude that the highlighted portion clearly infers that any individual expressions of opinion which *ARE* intended for public viewing or dissemination *ARE*, in fact, impermissible.

Bladen County Board of Elections member Patsy Sheppard has, on innumerable occasions, made startlingly clear that she is incapable of functioning as a non-partisan, unbiased board member. A representative sampling of her comments posted into online news media forums, as well as in emails forwarded to fellow board members, county party chairmen, and to the acting attorney for Bladen County's board of elections, demonstrates an unmistakable, unethical, and thoroughly unprofessional evidence of partisan prejudice. The following specific instances are noted:

- (1) Reader's comments which Sheppard posted between July, 2019, and September 2019, demonstrate that she is using her knowledge and position on the county board of elections to presumptively litigate the investigation into the background activities of Mr. McCrae Dowless, who is currently under indictment, but who has NOT, at this time, been convicted of any election-related crimes. Her comments are imperative, suggesting that she already KNOWS Dowless is guilty—before Dowless has even had a trial. This is not only unethical and improper, it suggests an illegal and public effort to taint the prospective outcome of Mr. Dowless' future appearance in court. These remarks are clearly outside the purview of a county board of elections member.
- (2) A second compilation of comments published into online news media reader's comments forums between April, 2019, and August 2019, clearly demonstrates Sheppard's palpable contempt for the Republican Party, and for certain individuals in particular, notably the President of the United States. Her name-calling is both snide, contemptuous, outrageous in context, and grossly immature. (In all instances, the comments are noted as to when they were posted, and to what article, and to what news media site, they are linked.) These sorts of comments are wholly inappropriate for a sitting board member to post into a public media platform, and they represent an inarguable and unacceptable level of bias.
- (3) Sheppard published a Letter To The Editor in the Tuesday, September 17, 2019 edition to the Bladen Journal in which, while attempting to decry the issue of election fraud in North Carolina, she not only makes a slur against a fellow sitting board member, but makes the clear inference in her letter that there are corrupt forces within the county—going back to 2004—which have impeded investigations into voter fraud. Again, it is correct to note that, while her comments and observations may be wholly suitable coming from an unelected or unappointed individual, in this particular instance her comments can only be construed as representing a factual, legal opinion. Since she sits on the county's board of elections, ipso facto, her letter represents a settled legal opinion from the county board of elections. Clearly, this is a violation of ethics, and is not only wholly impermissible and unprofessional, it falls completely outside the scope of her authority.
- (4) On Aug 29, 2019, Sheppard forwarded an email to myself, the Democrat Party chairman, her fellow election board members, and to the county attorney, putting herself on 'official record' noting her opinion regarding a discussion which was held two days prior regarding her husband acting as a poll observer. As noted in other areas in dispute, Ms Sheppard appears to use this email as an opportunity to attack, vilify, and disparage the Republican Party, as well as certain Republican Party members in the county. I found her remarks so incorrect, so egregious, and so palpably contemptuous,

that I forwarded the email to Katelyn Love, Acting General Counsel, along with my evaluation of the email. As I noted in my email response, I did not evaluate her email as helpful, but rather as an attempt to intimidate, and/or to threaten me in some unspecified way. I am including copies of those emails in an effort to further clarify the *astounding* level of unethical and unprofessional behavior which Ms Sheppard evidences.

Taken together, *all* of these instances of biased behavior represent an outrageous and aggressive attempt to marginalize and to delegitimize the Republican Party of Bladen County. This is unacceptable, and is wholly contrary to the spirit of the board of elections oath of office to well and truly execute the duties of that office. With respect to these many documented instances of prejudicial behavior, it is strongly recommended that Ms Sheppard be removed from her position as a member of the Bladen County Board of Elections. She demonstrates neither the will, nor the conduct, to function in a professional and non-biased capacity.

The following comments from Patsy Sheppard demonstrate personal opinions clearly intended for general public distribution or dissemination to the public at large, since they were freely and openly published on The Robesonian news site.

While personal expressions of opinion are allowable under N.C. General Statute para 163A-796, comments that are published and readily available to the public, and which suggest a partisan or prejudicial political bias, or which suggest a settled legal opinion from an appointed election board official, are not. The comments noted below appear to be in violation of this General Statute.

I would like to address a comment made at a Sept. 10 Board of Elections meeting. A Republican board member said that McCrae Dowless would never have been accused of election fraud if he was a Democrat.

Complaints have been filed about McCrae Dowless's illegal practices by both Republicans and Democrats alike since at least 2004. Those complaints led to several years of investigation by state election officials and multiple referrals for prosecution by investigators.

For the official record, I want it noted that on August 20, 2019 Bladen County Board of Elections member Emery White expressed in am open public meeting his opposition to Dwight Sheppard's (my husband) service as a volunteer poll observer for the Democratic Party in the 2019 Special Election for the 9th District Congressional seat. Mr. White's comments were followed by Bladen County Republican Party Chairman Wayne Schaeffer's remarks about the possible "public perception" of my husband's presence in a polling place.

On August 27, 2019, neither Mr. White nor Mr. Schaeffer expressed any such concern about Mr. Schaeffer's appointment of Bobby Ludlum to the same position for the Bladen County Republican Party, despite the fact that Mr. Ludlum is a near relative (Mr. Ludlum has at various times said it is uncle or cousin, perhaps it is both) to McCrae Dowless.

For clarification, Dwight Sheppard assisted in the investigation of election fraud in Bladen County, and McCrae Dowless committed the election fraud in Bladen County according to multiple indictments. I was appointed to the Bladen County Board of Elections in 2019. Mr. Ludlum's reappointment to the same board was rejected because of the election fraud committed by his relative during Mr. Ludlum's previous terms on the board.

The shameless hypocrisy of the entire Bladen County Republican Party organization was on full public display on August 27, 2019 and I would have gladly pointed it out it Tuesday's meeting except for the presence of a national journalist who is making a documentary about the history of election fraud in Bladen County.

Our county certainly needs no more public evidence of the corruption of the entire electoral process that has been pervasive systemwide, including among board members and party chairs. I had thought that perhaps we were all equally committed to ending that corruption and working together in a bipartisan manner to restore integrity to the elections process in Bladen County. Additionally, the appointment of G.C. Bryan as a poll observer has elicited comments of concern from some election employees who know his history of disrespect and mistreatment of minorities and women, including his own wife, all three of our female board members, and numerous others. Those elections employees have been instructed to have the chief judge or crew leader immediately and permanently eject from the polling place any poll observer that behaves in a disruptive or inappropriate manner.

Ms Love --

Please note the attached formal email which I received from Bladen County Democrat election board member, Patsy Sheppard. You will note that the tenor of the email makes it clear that the intent of the email is not to inform, but rather to discredit or disallow my choices for poll observers to enter any polling location, on the premise that their mere presence will be 'disruptive or inappropriate'. I assess this email as threatening, to say the least.

In her rather lengthy narrative, she fails to note that, during the Aug. 20 BOE session, I countered Mr. Emery White's opinion about her husband serving as a poll observer, and that, in fact, I affirmed that the Democrat Chairman had every authority, as acting head of the county's Democrat Party, to recommend whomever he chose. My comment about 'public perception' was to the extent that, while I understood he (Dwight Sheppard) is her husband (and thus, quite possibly biased), nevertheless, it was within the purview of the Dem Chairman to make the recommendation, and that I would not post any objection. In fact, I made a further remark noting that I was quite sure both he, and she, understood their ethical and professional responsibilities while acting in their capacities during this election. Interestingly, she doesn't seem to recall that remark from me.

Based on innumerable public comments which she has posted on reader's comments forums online regarding her personal dislike of the individuals whom I have selected as at-large poll observers, I fully expected her to challenge my choices. Nevertheless, I made it clear to the entire board that I was willing to ignore the clear perception of bias that recommending her own husband as an observer created. Clearly, the intent of the attached email from her is not to inform, but to intimidate, and/or to harass.

Regarding the gentlemen whom she references -- Mr. Bobby Ludlum sat on the county board of elections for many years, was well regarded by his peers, and is well-versed and very knowledgeable about the election process. However, he is ALSO quite knowledgeable about the history of mis-performance and malfeasance regarding this board in earlier election cycles. This evidently represents an unacceptable threat to her. Mr. GC Bryan is another matter altogether. Mr. Bryan is a retired insurance broker, and has a past history of spousal abuse. He acknowledges that, and acknowledges that both he and his wife have had many hours of counseling, in order to move beyond their conflicts. While I respect Ms Sheppard's personal feelings about him, those personal feelings and public insinuations about his character have no bearing on his ability to perform ethically and professionally as an atlarge poll observer.

I note that her 'on record' email addressees includes Bladen County attorney Allen Johnson, who serves in an adjunct advisory capacity with the Bladen BOE. I do not know if she 'vetted' her email narrative with him first, but I am noting his receipt of her email. In light of the previous email which I have forwarded to you regarding ethics violations, I assess this attached email from Ms Sheppard as a threat, and a direct attempt to intimidate both myself, the gentlemen whom I have selected as observers, and to Bladen County's Republican Party. This is rapidly becoming an unmanageable and outrageous farce, and it appears to represent an ongoing attempt by this board member to delegitimize and to discredit Bladen County's Republican Party. Thus, I am urging your office to investigate and to evaluate the attached email, and along with the ethics violations I noted in the earlier email, to take prompt and decisive actions to halt these threatening, partisan efforts at intimidation, up to and including the removal of the offending board members.
