Instructions (08 NCAC 03 .0101)

Any voter desiring to bring charges of a violation of the North Carolina Administrative Code or of Chapter 163 of the North Carolina General Statutes with the State Board of Elections against a member of any county board of elections may do so by filing with the Board a written statement, signed and sworn under oath or affirmation of the voter. The statement must contain:

1) the name, residence address, and county of the member against whom the charges are brought;

- a statement of the facts constituting the violation alleged, with a reference to the date and place of such misconduct; and
- 3) the names and addresses of persons who have knowledge or information of the matters EDARD OF ELECTION to in the charges as filed.

It is noted that Bladen County Chairperson Louella P. Thompson has posted several facebook posts that are clearly meant to disparage the sitting President of the United States. (see the attached screenshot copies)

Any reasonable person reading North Carolina General Statute 163A-796 would legitimately note that, while individual expressions of opinion are allowed, those intended for public distribution are not. Thus, anything intentionally posted into a social media website *is* intended for public distribution. These disparaging posts clearly fall outside the allowable parameters of the General Statute. Further, since it is noted that they were posted at two different times, this sort of biased activity can legitimately be construed as constituting a trend which is representative of a general mindset that is contradictory to the objective non-partisanship required by her position as Chairperson of the Bladen County Board of Elections.

Please note also that the attached screenshots are current as of 9/30/2019. Thus, they have been viewable by the general public for several months. These disparaging, unethical examples of prejudicial partisan bias represent an unacceptable standard of behavior from a chairperson, and unequivocally warrant consideration for censure, and/or formal removal from her position on the county board of elections. While her political party preference is entirely a personal preference to which she is entitled, her derogatory expressions of opinion in a public forum are impermissible.
