Re: Revocations of Signatures From North Carolina Green Party Petition

Dear Chair Circosta, Executive Director Brunson, and Members of the Board:

I write to inform you of the fact that a growing number of signatories to the North Carolina Green Party's petition to qualify as a political party are choosing to revoke their signatures in accordance with North Carolina law. Many of these voters are choosing to revoke their signatures because they feel they were misled as to the purpose of the petition, while many others are choosing to revoke after reconsidering their initial decision to sign after more carefully weighing the matter. As I explained in a separate letter, the North Carolina Green Party's signature gathering process was deeply flawed and purposefully designed not to inform voters about the Green Party's purpose and intent. I therefore anticipate that additional signatories will choose to revoke their signatures in the coming days and reserve the right to supplement this letter with additional revocations.

Attached to this letter are:

- 81 declarations signed under penalty of perjury by signatories requesting to revoke their signatures from the petition (Exhibit A);
- 29 affidavits executed by signatories requesting to revoke their signatures from the petition (Exhibit B);

- 35 declarations signed under penalty of perjury by signatories stating that they were misled by Green Party circulators and requesting that their signatures be revoked from the petition (Exhibit C);
- Three declarations signed under penalty of perjury by purported signatories who did not in fact signed the Green Party’s petition—they also request that their names be removed from the petition (Exhibit D).

North Carolina law has long recognized that citizens may revoke their signatures from petitions before any final action is taken upon them. See *Conover v. Newton*, 256 S.E.2d 216, 223 (N.C. 1979); *Idol v. Hanes*, 14 S.E.2d 801, 802 (N.C. 1941); *Armstrong v. Beaman*, 105 S.E. 879, 880 (N.C. 1921). As our Supreme Court has explained, such “second thoughts are apt to be sounder.” *Idol*, 14 S.E.2d at 802. “[T]his conviction has led courts to consider the right of withdrawal favorably, both as a matter of justice to the individual, who is entitled to apply his best judgment to the matter at hand, and as sound policy in community and public affairs.” *Id.*

The State Board of Elections should therefore respect the decision of these voters to withdraw from the Green Party’s petition and confirm that their names will not be counted in support of the petition.
