If the panel personally serves the order, service occurs when the order is handed to you. If the order is mailed, service will be deemed to occur three days after the order is put in the mail to you. The State Board will decide the appeal based upon the whole record of the hearing conducted by the panel. The hearing panel will forward a record of its proceedings to the State Board, including a copy of the original candidate challenge with any attachments, any written responses to that challenge, a copy of the panel's decision, a transcript, and any other pertinent documents (e.g., subpoenas, affidavits, depositions, notices, exhibits).

You must complete every section of the form and sign and date it. Make sure to answer every question below and include a valid email address. You will receive notice by email if the State Board schedules a hearing on your appeal. You may attach additional sheets in answering the questions, below. Sheets must be numbered. Please print or type your answers. Do not include material in this appeal that was not part of the record before the hearing panel.

NOTICE OF APPEAL

Appellant Joseph A. Gibson, III, hereby respectfully gives Notice of Appeal, and claims and says:

TENATIVE ISSUE OF APPEAL

I. The Decision to remove the Appellant from the State of North Carolina's Primary Ballot by Appellee, without service of notice of hearing, for said same reason, and convening, and holding, said hearing whereby the Appellant was not afforded the opportunity to present exculpatory evidence during said hearing, violates the Appellant's rights, privileges, and immunities, by denial of Due Process and Equal Protection of The Law, as secured by the United States Constitution, Amendments 5, 9, and 14, and the Constitution of North Carolina, Article 1, Sec. 19.

During the 2022 filing for notice of candidacy I did in fact fill out the felony disclosure forms informing the State board of elections of my prior history and record in connecticut from 1991.

On August 3 2022 A background check was conducted by the director of the private protective services board Paul Sherwin (See Attached) In this report there is no felony convictions disclosed or found, This candidates background check shows zero felony convictions found on his record from the point of establishing residency March of 2005. A report furnished by a elected official of a occupational license board should be trusted as true and accurate.

(See attached) A document received by this Candidate from a district court judge Grogan in Rockingham county States as of July 27 2022 says all rights of this candidate have been fully restored, has or did the challenger disclose this information to the board? 

Dear Mr. Gibson,

Congratulations on being nominated as a presidential elector candidate by your political party. I am writing to provide you with information which will be important to you as an elector if you are elected in the November general election.

Save the Date:

The date, time and location for the meeting of the electors are set forth in the United States Constitution and in the General Statutes of North Carolina as follows:

- **When?** Monday, December 14, 2020
- **What time?** Twelve o'clock noon
- **Where?** The Old State Capitol House of Representatives Chamber, Raleigh

Please put this date on your calendar now.

North Carolina law requires that the electors be present for the meeting. During the meeting the electors vote for President and Vice President and then sign and certify their votes. As we plan for the meeting, we are taking into account the necessary health and safety measures related to the COVID-19 pandemic. At this time, however, you should assume that if you are elected to the State office of elector, you will need to be present in Raleigh on the date and at the time and place shown above. We will provide you additional information in the event you are called upon to serve as a result of the November election.

Ban on Dual Office Holding:

North Carolina law requires us to notify you regarding a legal prohibition on an individual from holding two (2) elected positions at the same time. A presidential elector is an elected office holder under North Carolina law. The United States Constitution, the North Carolina Constitution, and the North Carolina General Statutes prohibit people from holding more than one office at the same time. This is called "dual-office holding" in North Carolina law.

- Section 9 of Article 6 of the North Carolina Constitution reads as follows:
 1. Prohibitions. It is salutary that the responsibilities of self-government be widely shared among the citizens of the State and that the potential abuse of authority

This order was issued to the applicant following an unsuccessful appeal to the Private Protective Services Board on April 20, 2023. This denial may be appealed to the Office of Administrative Hearings. If the applicant or the company wish to do so, a request to appeal must be submitted in writing to the Board no later than June 26, 2023.

You, the Licensee, are expected to take immediate and appropriate action to comply with this administrative action. If this applicant was denied for cause (as in this case) this denial may be appealed by the applicant or the company to the Administrative Procedures and Hearing Division, General Statute 150B. By filing an appeal, the applicant is afforded the right to be heard by the Administrative Procedures and Hearing Division. This appeal must be in writing and must be received by this office no later than sixty (60) days from the receipt of this notice. However, if the applicant fails to appeal within sixty (60) days of the receipt of this notice, the denial is final. Pursuant to the Administrative Procedures and Hearing Division, the applicant is not allowed to re-apply for a PPS Registrant Permit for a period of one (1) year from the date of the final denial.

Due to recent guideline changes, we will no longer provide the licensee/applicant with the criminal charge and/or conviction obtained via the fingerprint record checks or via NCDOJ search methods.
