Response to Request for Additional Information

Dear Mr. Steele and NCSBE Legal Department,

This document serves as a response to the request for additional information regarding the We The People Party's petition for recognition as a new political party, as outlined in your letter dated June 21, 2024. We appreciate your hard work and due diligence regarding our party formation and look forward to the hearing on Wednesday and finalizing our certification as a new political party for the people of North Carolina.

Transparency in governance is a core value of We The People, and in an effort to embody this principle, allow me to clarify our position succinctly: Our Party was unequivocally inspired by Mr. Kennedy and the principles of his current Presidential campaign. His vision served as the catalyst for our diligent efforts in North Carolina to gather the necessary signatures to establish our party thereby enabling us to nominate candidates who embody the ideals articulated in our Bylaws, detailed in our petition instructions, shared on our website (wethepeoplenc.com), and discussed with *the thousands upon thousands upon thousands* of North Carolina registered voters who signed our petitions. We have made every effort to follow any and all statutory requirements, and any assertions submitted to the Board to the contrary merely serve to obscure the democratic process.

As to your specific requests:

1. General Purpose and Intent of the We The People Party

The documents provided in May 2024, specifically the "Instructions for Petitioners" and the organization's Bylaws you reference, accurately reflect the general purpose and intent of the We The People Party. Below is a reaffirmation of the key elements outlined in these documents as relates to the general purpose and intent of the party.

- a. Establish a viable third independent party outside of the Duopoly (i.e., Republicans and Democrats).
- b. Nominating candidates like Robert F. Kennedy, Jr. and those committed to our core values.

Of course, we have been cognizant of the requirement set forth in N.C.G.S. § 163-96(b) that “the organizers and petition circulators shall inform the signers of the general purpose and intent of the new party” as is reflected by our training, documents, Bylaws, website, and signature gathering practices.

Additionally, I am attaching thirty (30) signed statements from petition signers attesting to our interactions with them during the petition signature gathering process (Exhibit A).

2. Details Regarding Signature Collection

In an effort to meet the statutory requirements set forth in N.C.G.S. § 163-96(a), and in conjunction with the Kennedy24 campaign, we worked with a signature-gathering firm, Accelelate LLC, for part of our petition circulation efforts. Their contact information is Kara Ramsey, Legal Counsel for Accelelate, LLC at (412) 916-0833. *However*, it is important to note that the majority of signatures were collected by unpaid, dedicated volunteers from across the state. These patriotic North Carolinians have tirelessly contributed to our cause, demonstrating their commitment to our party values and the democratic process.

As per your request, attached please find a document with the contact info we have on file for the volunteers that worked on the signature gathering efforts (Exhibit B).

Additionally, I am attaching thirty (30) signed statements from volunteers attesting to our training methods and the procedures followed during the petition signature gathering process (Exhibit C).

3. Training and Oversight of Petition Circulators

We conducted comprehensive training sessions for our petition circulators, ensuring that each participant was well-versed in the party’s purpose and intent and the requirements associated with the petition process. These sessions were led by David Owen, a professional ballot access specialist. I personally attended a training event with Mr. Owen in Raleigh, NC on January 12, 2024 as did many of the other We The People volunteers.

Additionally, I am attaching a signed Trainer Declaration from Mr. Owen, which details our training methods for the We The People petition signature gathering process (Exhibit D).

4. Additional Scripts and Talking Points

To my knowledge you have all of the documents related to scripts and talking points.

We are happy to discuss these matters further at the State Board meeting scheduled for June 26, 2024, and address any additional queries that may arise. We eagerly look forward to our certification so that we may commence our efforts for the people of North Carolina.

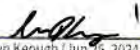

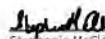

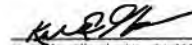
