The above-named candidate does not meet the following constitutional or statutory qualification(s) for the office:

1. The candidate's residence address, 601 S Kings Drive, F, Charlotte, NC, 28204, listed in the 1/4/2026 public NC voter registration file does not satisfy the residence defined for registration and voting at G.S. 163-57(1)c. The listed residence, The UPS Store at 601 S. Kings Drive, Charlotte, NC, 28204, provides mail delivery boxes and does not provide customer living accommodations and is not a valid residence.
2. Documents provided from the Florida Department of State Division of Elections dated 12/10/2025 report the candidate is probably a registered voter in Marion County, Florida, voter ID 1185944220, residence 2399 SW 107th Pl, Ocala, FL 34476. Florida documents report her date of birth as (redacted here) mm/dd/1967 and she last voted in Florida in the 04/01/2025 primary election.

This challenge is based on reasonable suspicion or belief of the following specific facts. (Attach evidence, if available.)

1. Margot Patrice DuPRE, NCID CW1597787, NC voter registration is invalid because she does not satisfy the residency requirements at G.S. 163-57(1)c.
2. Margot Patrice DuPRE, NCID CW1597787, residency cannot be determined and thus her candidacy for the United States Senate representing the State of North Carolina may be invalid.
