RE: Annual List Maintenance Report Pursuant to G.S. § 163-82.14(f)

DATE: September 30, 2022

The following report is submitted pursuant to G.S. § 163-82.14(f), which requires the State Board of Elections to compile annual list maintenance reports received from each county board of elections and submit the reports to the Joint Legislative Elections Oversight Committee on or before October 1 of each year. This report is also transmitted to the cochairs of the Joint Legislative Oversight Committee on General Government in accordance with G.S. § 120-308.

To compile this data, the State Board identified each record of a registrant who was removed during the reporting period. For each such record, the data reported herein provides the last reason for a list-maintenance action, as reported by the State Board's election information management system. As a consequence, this report does not reflect situations in which a registrant was removed due to one list-maintenance reason (e.g., felony conviction), but then a subsequent list-maintenance action has superseded that original removal reason (e.g., felony sentence completion). It also does not reflect registrants who were removed but were later reinstated.

Descriptions of the columns in the attached report are as follows:

- Deceased – Voter was removed because the county board of elections received notification of the voter's death either by a government entity or by the voter's near relative (G.S. § 163-82.14(b)).
- Felony Conviction – Voter was removed because the county board of elections received notification that the voter was convicted of a State or federal felony (G.S. § 163-82.14(c)).
- Felony Sentence Completed – As noted above, for many voters who are initially removed due to felony conviction, if they subsequently become eligible during the reporting period, their record will reflect this reason rather than felony conviction.
- Moved within State – Voter was removed due to the statewide duplicate check; voter registered in another North Carolina county and was matched to a registered voter in a previous county. (G.S. § 163-82.14(d)).

- Moved from State – Voter was removed because the county board of elections received notification of voter’s registration in another state (G.S. § 163-82.14(d)).
- Moved from County – Voter was removed because the county board of elections received notification of voter’s registration in another North Carolina county (G.S. § 163-82.14(d)).
- Voluntarily Cancelled – Voter was removed at his or her signed request (G.S. § 163-82.14(a)).
- Administrative Removal – Voter was removed due to an administrative action taken by the county board of elections (G.S. § 163-82.14(a)).
- Sustained Challenge – Voter was removed due to a sustained voter challenge under Article 8 of Chapter 163 of the General Statutes.
- Removed Duplicates – Voter was removed because the record matched an existing registered voter in the county (G.S. § 163-82.14(a)).
- Biennial List Maintenance – Voter was removed after remaining in inactive status for two federal general election periods pursuant to G.S. 163-82.14(d)(2) and Section 8 of the National Voter Registration Act (NVRA). Removals for this reason typically occur during the first half of odd-numbered years, in accordance with G.S. 163-82.14(a).
