RE: Annual List-Maintenance Report Pursuant to G.S. § 163-82.14(f)

DATE: October 1, 2025

The following report is submitted pursuant to G.S. § 163-82.14(f) and G.S. § 120-308, which require the State Board of Elections to compile annual list-maintenance reports received from each county board of elections and submit a compiled report to the above-named committees and the Fiscal Research Division on or before October 1 of each year.

To compile this data, the State Board identified each record of a registrant on the statewide voter registration system who was removed from the rolls during the reporting period. For each such record, the data reported provides the last reason for a list-maintenance action, as indicated in the State's election information management database. As a consequence, due to the limitations in the capabilities of the database, this report does not reflect situations in which a registrant was removed due to one list-maintenance reason (e.g., felony conviction), but then a subsequent list-maintenance action has superseded that original removal reason in the database (e.g., felony sentence completion). It also does not reflect registrants who were removed during the past year but were subsequently reinstated by re-registering according to the eligibility criteria in law.

Descriptions of the columns in the attached report are as follows:

- Deceased – Voter was removed because the county board of elections received notification of the voter's death either by a government entity or by the voter's near relative (G.S. § 163-82.14(b)).
- Felony Conviction – Voter was removed because the county board of elections received official notification that the voter was convicted of a State or federal felony (G.S. § 163-82.14(c)).
- Felony Sentence Completed – As noted above, for many voters who are initially removed due to felony conviction, if they subsequently become eligible during the reporting period, their record will reflect this reason rather than felony conviction.

- Moved within State – Voter was removed due to the statewide duplicate check; voter registered in another North Carolina county and was matched to a registered voter in a previous county. (G.S. § 163-82.14(d)).
- Moved from State – Voter was removed because the county board of elections received notification of voter’s registration in another state (G.S. § 163-82.14(d)).
- Moved from County – Voter was removed because the county board of elections received notification of voter’s registration in another North Carolina county (G.S. § 163-82.14(d)).
- Voluntarily Cancelled – Voter was removed at his or her signed request (G.S. § 163-82.14(a)).
- Administrative Removal – Voter was removed due to an administrative action taken by the county board of elections (G.S. § 163-82.14(a)).
- Sustained Challenge – Voter was removed due to a sustained voter challenge under Article 8 of Chapter 163 of the General Statutes.
- Merged/Removed Duplicates – Voter was removed because the record matched an existing registered voter (G.S. § 163-82.14(a)).
- Biennial List Maintenance – Voter was removed after remaining in inactive status for two federal general election periods pursuant to G.S. 163-82.14(d)(2) and Section 8 of the National Voter Registration Act (NVRA).
- Non-Citizen – Voter was removed because they requested to be excused from jury service on the basis that they are not a U.S. citizen, and a review of available information in state and federal databases did not reveal they had since become a U.S. citizen (G.S. § 163-82.14(c)1). Some counties also have used this code when a voter’s registration is cancelled on the basis that they are not a citizen, even if it should have been assigned one of the other status codes listed above (i.e., voluntary cancellation).
