Progress Report on Gordon Park

Director Bissias stated the Gordon Park project is moving along. The grass would be installed this week. The playground and splash pad were installed. The project is under budget and will be open for Rocktoberfest at the end of the month.

# *Update of Other Park District Matters*

Director Bissias informed the Board of vandalism over the weekend. The Community Gardens at Denning Park were damaged and there was graffiti at Sawyer Park.
