# Update on PDLG/LGBA Endless Summerfest

Director Bissias stated the Endless Summerfest committee will meet next week, however preliminary numbers estimate about a \$20,000 profit. The \$30,000 put in originally was never touched. Everyone agreed there was positive feedback from the public for the event. Commissioner Ashby was concerned about the Park District recouping all our labor costs. Director Bissias and Superintendent of Finance Kuniej stated they would review our labor cost for the event.

## Update of other Park District Matters

Director Bissias distributed the safety management information to the Board for their review. He stated they would discuss this and vote on it at next month's board meeting. They should direct any comments to Commissioner Walsh.

Director Bissias received the traffic light information at Denning Park from the Village. The bid was much higher than expected from \$320,000 to \$360,000. Director Bissias stressed to the Board that the Park District has spent all we are spending on this project with the construction of new entrances to the park. He will notify the Board when the Village responds.
