Regular Meeting of the Board of Commissioners Community Park District of La Grange Park November 12, 2012

1. CALL TO ORDER & ROLL CALL

President Ritten called the meeting to order in room 101 of the Recreation Center, 1501 Barnsdale Road, La Grange Park, IL at 6:31 pm.

5. APPROVAL OF MINUTES

Regular Meeting: October 8, 2012

Commissioner Boyd made a motion to approve the minutes as amended; Commissioner Stastny seconded. <u>MOTION CARRIED</u>. There was no further discussion and the motion passed by unanimous voice vote.

6. STAFF REPORTS

A. Executive Director

A written report was submitted prior to the meeting by Roy Cripe. A 6:00pm start time for the December meeting was proposed and accepted in order to accommodate the annual Holiday Party following the Board Meeting. Questions about the status of electricity to the new LaGrange Road sign were asked and answered, as were questions about the Grant Proposal presentation in Springfield.

B. Buildings and Grounds

A written report was submitted prior to the meeting by Martin Healy. The Fire Department will again be helping with the ice rink installation this year. Liners will be inspected next week.

C. Superintendent of Recreation

A written report was submitted prior to the meeting by Dean Carrara. The summer financial report was not attached as stated in the written report. It will be sent out.

A written report was submitted prior to the meeting by Darla Goudeau. Questions were asked and answered.

G. Financial Report

7. APPROVE MONTHLY DISBURSEMENTS

Commissioner Stastny made a motion to approve the monthly disbursements as amended in the amount of \$361,222.56; seconded by Commissioner Boyd. <u>MOTION CARRIED.</u> There was no further discussion and the motion passed 4-0 by roll call vote. Commissioner Kilrea was not present.

8. OLD BUSINES

A. Levy Ordinance - 2012

After questions were asked and answered, Commissioner Boyd made a motion to approve the 2012-20 Levy Ordinance; seconded by Commissioner Stastny.

MOTION CARRIED. There was no discussion and the motion passed 4-0 by roll call vote. Commissioner Kilrea was not present.

B. Final Review: 2012-2016 Outdoor Facilities Master Plan:

Executive Director Cripe thanked President Ritten and Commissioner Boyd for input regarding wording and grammar on the final document. Several improvements were made without compromising the substance of the plan. Mr. William Yena noted that former Executive Director John Hecker's name was inadvertently left off the history. It will be added. President Ritten stated that public comment on the plan will be encouraged and welcomed. The plan is meant to be flexible but is presented as the best plan for today. Commissioner Boyd made a motion to adopt the 2012-2016 Outdoor Facilities Master Plan as a working document subject to final community comments with the recommendation it be presented to the community in December; seconded by Commissioner Stastny. MOTION CARRIED. There was no discussion and the motion passed 4-0 by roll call vote. Commissioner Kilrea was not present.
