ORDINANCE No. 14-09

AN ORDINANCE abating the taxes heretofore levied for the year 2014 to pay debt service on General Obligation Bonds (Alternate Revenue Source), Series 2006, of the Park District of La Grange, Cook County, Illinois.

WHEREAS, the Board by ordinance adopted on the 16th day of February, 2006 (the "2006 Ordinance"), did provide for the issue of \$2,855,000 General Obligation Park Bonds (Alternate Revenue Source), Series 2006 (the "2006 Bonds"); and

WHEREAS, the 2006 Ordinance, as amended by the Direction to Abate Taxes dated February 28, 2006, and filed with the Cook County Clerk on March 7, 2006 (the "Ordinance") provides for the levy of a direct annual tax sufficient to pay debt service on the bonds issued under the Ordinance (the "Pledged Taxes"); and

WHEREAS, a duly certified copy of the Ordinance was filed in the office of the County Clerk of Cook County, Illinois (the "County Clerk"); and

WHEREAS, the District has or will have Pledged Revenues (as defined in the Ordinance) available for the purpose of paying debt service on the 2006 Bonds (the "Bonds") heretofore imposed by the 2014 levy; and

WHEREAS, the Pledged Revenues are hereby directed to be deposited into the "Alternate Bond and Interest Fund" (the "Bond Fund") established pursuant to the Ordinance for the purpose of paying debt service on the Bonds; and

WHEREAS, it is necessary and in the best interests of the District that the taxes heretofore levied for the year 2014 to pay debt service on the Bonds be abated.

NOW, THEREFORE, Be It Ordained by the Board of Park Commissioners of Park District of La Grange, Cook County, as follows:

Section 1. Abatement of Tax. The tax heretofore levied for the year 2014 in the Ordinance shall be abated by that amount representing funds available or to be available in the Bond Fund, and the amounts of the taxes levied in the Ordinance for the year 2014 to pay debt service on the Bonds, the amount of the taxes to be abated for said year, and the remainder of the taxes levied which are to be extended for said year to pay debt service on the Bonds are as follows:

Section 2. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the Secretary of the Board shall file a certified copy hereof with the County Clerk and it shall be the duty of the County Clerk to abate said taxes levied for the year 2014 in accordance with the provisions hereof and as shown hereinabove in Section 1 hereof.

Section 3. Effective Date. This ordinance shall be in full force and effect forthwith upon its adoption.
