

SEC Rule 606 and 607 Disclosure of Payment for Order flow and Order Routing Information

Tradier Brokerage Inc. ("TBI") is required under SEC Rule 606 and 607 to make publicly available a quarterly report and discloser regarding payment for Order Flow practice. Apex Clearing, TBI's clearing firm directs all order to the exchanges for execution and publishes quarterly statistics regarding its customer agency order routing practices and payments for order flow. TBI does not route orders direct to exchanges for execution. The purpose of the report is to provide the pubic with information on how order routing practices are handled for TBI customers' orders and to enable customers to evaluate order routing practices. The report is published by the end of the month following the calendar quarter reported. This information is available within the link below and in hard copy upon written request. In addition to the quarterly reports, you may request the venue to which of your orders were routed for execution in the six months prior to the request, and the time of the transactions, if any, that resulted from such orders.
