- Coordination with other providers is one of the purposes
 - Jeff Baker: Primary objective is to provide more service to people or addressing the unmet needs. Secondary objective is to coordinate to efficiently use state/fed funds.
 - Jerry Deichert: There needs to be an introduction or orientation session for RCC which explains the roles and responsibilities for the members
 - Handbook/Guidelines
 - What are the tools/technology at their disposal
 - Bob Blair: Mechanisms for collaboration (formal and informal)

RCC Organization

- Mobility Manager leads and facilitates the next RCC meeting
- When hiring a Mobility Manager after pilot period, NDOT makes the decision but RCC can provide feedback on candidates/proposals.

Mobility Manager

- Mobility Manager does outreach and travel training
- Jeff Baker: Marketing needs, College students need alternative method than calling for scheduling rides. (QR code, text, mobile app?) – Smita is working on finding the appropriate subscription to make the text service/email reservation concept work.
- Regional Trip Calendars that can be shared with providers – Smita is working on finding the right subscription service that make this work.
- Jerry and Bill Bivin can help with outreach. Smita will update the recipient email list.
