Kyäni Emerald Trip

Each year Kyäni takes qualifying Emeralds and higher on a memorable and rewarding trip for a few days of information, inspiration and relaxation.

Eligibility Requirements:

- Any Distributor who achieves paid-as-rank Emerald for the first time and maintains paid-as-rank Emerald or above for 5 additional months out of 12 rolling months (July 1, 2017 - June 30, 2018) will be eligible to attend the Emerald Trip.
- Any previous Emerald Trip qualifier who personally sponsors a qualified first-time Emerald will also be eligible for the Emerald Trip.
- Distributors who attended a previous Emerald Trip (or Leadership Retreat) may attend the Emerald Trip again at their own expense. The Kyäni events team must receive at least a 90-day advance notice of intention to attend. Price and availability will be subject to change.
- Each Distributor who qualifies to attend the Emerald Trip or who is paying their own way must be at least paid-as-rank Ruby or above in the last qualifying month of the trip he or she attends.

Reward Trip Includes:

- Hotel accommodations on designated trip days for the qualified Distributor plus one guest.
- Select group meals and activities.
- Trainings by corporate and key market leaders.

Notes:

- The trip is non-transferable and has no cash value.
- Transportation to/from event will be covered by the individual, not Kyäni.
- Cancellation within 60 days of the event will result in a \$1000 USD cancellation fee per person.
- The qualified Distributor may elect to attend the following year's Emerald Trip if the Kyäni events team receives postponement notification at least 90 days prior to the start date of the trip, and if the Distributor can maintain minimum rank requirement in the last month of the eligibility period before the trip.
- Should more than one personally sponsored new Emerald qualify for the trip, the Sponsor is entitled to one trip per new Emerald, to be attended during consecutive years.
- Should the Sponsor qualify for his or her own trip during the same year that a personally sponsored new Emerald also qualifies, the Sponsor may postpone one trip to the following year.
- Previous attendees of the Leadership Retreat will not be eligible for the Emerald Trip as a first-time Emerald Trip qualifier; however, they may attend as the Sponsor of a newly qualified Emerald.

Disclaimers:

- All attendees must be at least the age of 18.
- Moved volumes are not eligible.
- The interpretation and decision about the rules of the trip by Kyäni corporate are final, and are not subject to review. Kyäni reserves the right to amend the rules of this trip at any time.
- In the event that any of the winners are a corporation, limited liability company, or partnership, said entity shall be entitled to one award.
- All attendees must be in good standing with Kyäni at the time of the Trip in order to participate.
