Retailer/Distributor Agreement

This agreement is between NOVEL CREATIONS USA INC (the manufacturer of NU SENSUELLE), hereinafter referred to as the "MANUFACTURER" and WILLIAMS TRADING COMPANY hereinafter referred to as the "DISTRIBUTOR". A customer who the "DISTRIBUTOR" sells to is referred to as the "RETAILER".

Purpose of Agreement

This agreement sets forth the terms and conditions by the MANUFACTURER, under which WILLIAMS TRADING COMPANY will be permitted to sell said product line in the USA and is limited to sales in the USA.

Terms of Agreement

Unless terminated hereinafter, this agreement shall remain in force indefinitely and govern all transactions between the parties relating to the above referred product line.

(Removal of Acceptance of orders for Retail MAP agreement)

Minimum Advertised Pricing (MAP) Policy

This policy applies to, but is not limited to, advertising in catalogues, direct mail, websites, in-store displays and any and all other forms of advertising media, including, without limitation, the internet and any other electronic medium available to the general public.

Rebates, coupons, credits, percentage discounts or any manner of discounting which results in a net advertised price below MAP, regardless of any other circumstances, will be considered as not complying with the (MAP) policy. Selling on Amazon, EBay or 3rd party sites without written permission is strictly prohibited.

In the event that MANUFACTURER receives information that a party is advertising a NU SENSUELLE product below the minimum advertised price (MAP), the DISTRIBUTOR must contact the noncompliant party. The DISTRIBUTOR will then request the noncompliant party to comply with the minimum price within ten (10) days. If after ten (10) days the pricing has not been corrected, the MANUFACTURER may, at its sole discretion, cease future supply of the product to the DISTRIBUTOR of the noncompliant party.

The DISTRIBUTOR must enforce that the RETAILER may not directly or indirectly discount said advertised prices in any manner whatsoever, including but not limited to providing free products or accessories to its customers, providing promotional coupons/ giveaways/sales, or by discounting the otherwise standard shipping cost to its customers.

Should a RETAILER fail to comply with the minimum advertised resale price provision, the DISTRIBUTOR must cease selling to this RETAILER. The MANUFACTURER shall have the right to immediately terminate sales to the DISTRIBUTOR if the MAP policy is not enforced by the DISTRIBUTOR under this agreement. This applies to designated URL websites, as well as 'Storefronts' under the blanket sites (EBay, Amazon, etc.).

In order to protect the integrity of the NU SENSUELLE product line and its DISTRIBUTOR/RETAILER network, the RETAILER who the DISTRIBUTER sells to may not advertise the resale price of the product for less than the price set forth below, which excludes shipping and handling charges:
