Track Passes

We have new Track Passes for parents to use while you are waiting for your dancer. These passes allow you free use of the indoor track, as well as 50% off the inflatable playground (\$5), fitness classes (\$10), and the Fitness Center (\$5). Parents can check passes out at our front desk.

The Mill Works

We hope you are enjoying our new home as much as we are. Here are a few reminders about our use of the building.

- Please enter the building by using our door up the pathway, or the front entrance of The Mill Works. Please refrain from using the side door.

- Unless you are a member of The Mill Works, families are not permitted to roam the building. If you must leave the studio, please check out a Track Pass and use only the permitted areas. Think of us as a shopping mall, we are only a small business inside of a very large building. We do not have access to anything but our studio spaces.
- Because we are in such a large building with a lot of traffic, children should **never** be left unattended outside of class time. Young dancers must wait in the studio for their parents to pick them up. Please do not drop dancers off more than ten minutes prior to class time. If you are early, parent or guardian **MUST** stay with the child.
