



# 2024 June Recital Rules & Regulations

*We like to keep our 4SDA Parents informed! Please read through this PDF before registering!  
You will be required to digitally sign and accept these rules & regulations when registering.*

## **PRODUCTION FEE**

I agree to the one-time production fee of \$50 per student/dancer. This fee helps cover the extensive production costs including, but not limited to: rehearsals, music licensing, backdrops, equipment, props, technical labor, administrative labor, venue rentals and associated costs. Tickets to the performance will be sold separately.

## **COSTUMES**

I understand that each class in the Spring Performance has a specific costume and that the cost of the costume, approximately \$70 to \$85 per costume, is posted as "Tuition" when I register my student/dancer online. I agree to pay the cost of the costume(s) and that the funds paid are non-refundable. Should I withdraw my dancer from the June Recital, or should they be unable to attend, no refunds will be given, but I will be able to pick up the costume(s).

## **REHEARSALS / DRESS REHEARSAL**

Rehearsals will start in February/March 2024 and will be held during each class. Older students with more elaborate choreography may require additional rehearsal time outside of their scheduled classes. This includes, but is not limited to D2-D6 Ballet classes, Musical Theatre, and Eleve 1 & 2. A mandatory dress rehearsal, outside of class, prior to the performance date(s) will be held at the theatre for all students. Updated rehearsal schedules and the dress rehearsal schedule will be posted in the studio window and online in advance.

## **ATTENDANCE & TARDINESS**

Prompt attendance to all classes and any scheduled rehearsal is mandatory. I understand that missing multiple classes may result in reduced choreography for my dancer or that my dancer may be removed from the production.

## **PROMPT DROP-OFF / PICK-UP**

We will drop-off and pick up our dancer(s) promptly to scheduled rehearsals. It is understood that 4S Dance Academy and/or its agents will not be responsible for any dancer supervision other than during the rehearsal time.

## **VOLUNTEERING**

We always need your wonderful help! Every successful production is only made possible by the amazing work of Parent Volunteers. We have many fun and rewarding committees that we hope you will join. There are opportunities to help before, during and after the Spring Performance so please know that there is something you can help with! Our goal is to have every family with a dancer performing volunteer to help in some way whether it is with costumes, security, chaperoning, programs, flowers.... the list goes on! The more help we receive the smoother the production will be!

## **ILLNESS & FAMILY EMERGENCY**

In the event of illness or family emergency, I understand that it is my responsibility to contact Mr. Jason prior to the dress rehearsal and/or performance(s). I will email [jason@4sdanceacademy.com](mailto:jason@4sdanceacademy.com) or call the studio office (858) 385-1999. Each case will be assessed individually. Multiple absences may result in removal from the production.

## **CHANGES DUE TO COVID-19 RESTRICTIONS**

In the event that 4SDA or the Performance Venue is required to limit or prohibit live audience attendance or close operations due to required safety measures and protocols, I understand that 4SDA will continue rehearsals online and that contingency plans have been made for the performance(s). Possible plans include but are not limited to holding the performances at a different venue, outdoor, live-streaming and/or filming scenes to be edited into a mini movie. I further understand that refunds will not be given as contingency plans are in place and the goal is to have our dancer(s) perform.

### **CODE OF CONDUCT**

As a parent/legal guardian, I agree to behave in a courteous manner toward teachers, staff, students and other parents. I understand disrespectful, disparaging and / or disruptive behavior of any kind will be grounds for immediate dismissal from the production. Students are required to arrive on time, remain quiet, attentive and respectful at all times, while also abiding 4SDA's general rules of conduct. Students who seriously or continually misbehave will be removed from the production. No refunds will be given. I understand this conduct code applies to all who participate in the spring recital, as well as their families, friends and caretakers.

### **PHOTOGRAPHIC RELEASE**

We understand and agree that for promotional, publicity or commercial advertising purposes, 4S Dance Academy shall have the right to use a photograph, video, voice or other likeness of my student dancer.

### **NO PHOTOGRAPHY OR VIDEO RECORDING**

Please do not film or take pictures during the performance. We love our parents, but we know the excitement can cause parents with the best intentions to leave the flash on, stand in front of other people and simply distract their own child from performing. We have contracted a theatre approved Photographer & Videographer. They are pros and they will get the best shots of the dress rehearsal and footage of the performance, while you simply enjoy watching your dancer shine on the big stage!

### **LIABILITY RELEASE:**

As additional consideration for the student's instruction, the undersigned hereby releases and holds harmless 4S Dance Academy and/or any of its agents or representatives from any liability whatsoever arising out of injury, illness including COVID-19, and/or damage to the person or property of the student which may occur while participating in the activities of 4S Dance Academy or its affiliated Company. The undersigned further agrees to indemnify 4S Dance Academy in the event any claims are asserted against it arising from the student's participation. I (we) understand and agree that by participating in any physical activity, there are risks for injury, bodily harm and illness and agree to assume all such risks.

**Participation in the 2024 June Recital is contingent upon adherence to the rules set forth in this waiver/agreement and the Performance Packet. Production and Costume fees will not be refunded for any reason. Partial account credit may be considered on a case-by-case basis for injury, family emergency, and/or extended illness/isolation/quarantine due to COVID-19.**
