WHEREAS, a change in circumstances regarding projected revenue and expenditures occurred making it appropriate to amend the Fiscal Year 2017-2018 budget, and


WHEREAS, each fund budget shall not exceed their appropriation per Florida Statute 166.241:

1. That the budget for the Fiscal Year 2017-2018 of the Town of Dundee is hereby amended as detailed on Exhibit "A" as attached hereto.




