## September 2014 National Geographic Retronaut Giveaway

Once landing on the National Geographic Books page you will be directed to the *Retronaut Giveaway* Sweepstakes Application. To enter, complete the information requested by the Sweepstakes entry form (the "Entry Form".) Once the form is complete, click the "submit" button.

Limit one (1) entry per person during the Sweepstakes Period. Entries become the property of Sponsor. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any entry, the authorized account holder of the email address connected to the Facebook account that is used to enter will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address.
