- 2. Open only to legal residents of the 50 United States and the District of Columbia, Puerto Rico and Guam who are 18 years of age or older and who have reached the legal age of majority in their state, jurisdiction or territory of residence at the time of entry.
- How to Participate: During an Entry Period, you (the "Entrant") can enter and play by visiting www.EBFamilyMealsPledge.com; then completing and submitting the official Family Meals Pledge form by providing your first and last name, street address, city, state/territory, zip code, e-mail address, phone number (including area code), and confirming your agreement to the pledge for a chance to win an Instant Win Prize (the "Game Play") and one (1) entry into the Grand Prize Drawing (an "Entry"), as described below.
