- I. The meeting was called to order at 7:00 PM
 - a. Pursuant to the authority MD Code Corporations & Associations Section 2-409(d), the Vestry held a telephonic meeting in which the people listed above participated.
 - b. The Sr. Warden declared a quorum present.
 - c. The Vestry members could hear all others participating in the telephonic meeting.
 - d. Each person had an opportunity to express opinions on the subjects discussed and to cast a vote on motions.
- II. A motion was made by Jane Rozes and seconded by Karla Davis to accept the 2021 parish budget as presented.
 - a. Pledge income shortfall is \$7,000
 - b. Motion passed
- III. Mutual Ministry Review
 - a. The Rector presented the results of the Mutual Ministry Review conducted by Canon Scott Slater with the Vestry
 - i. Issues
 - 1. Young Families
 - a. There is general anxiety about the lack of young families in the parish
 - b. How realistic is it to expect the Rector to address this issue
 - c. Should focus on diversity and parish evangelism
 - d. Need to understand the demographics of the region
 - 2. Market the Parish
 - a. Look at churches in the region that are thriving to gain ideas as to how to attract new members
 - b. Ask the Diocese for assistance in developing a marketing plan
 - c. Developing a marketing plan is one of the recommendations in the Welcoming Commission's annual report
 - d. Pandemic has freed the parish to try things that would not have been considered in the past
 - e. Should establish short term and long term goals
 - Goals are like budgets sometimes there are surpluses and deficits
 - ii. Reviewing parish mission statement would be a good start
 - iii. Planning also involves getting feedback from the parish; a consultant might be helpful

- f. The consensus of the Vestry was to start a strategic plan initiative
- g. The Rector will contact the Diocese about strategic plan resources
- 3. Define Expectations of the Vestry & Commissions
 - a. What is the Vestry liaisons' role on the Commissions
 - b. Who is responsible for taking minutes at Commission meetings
 - c. Need to improve the responsibilities and structure of the Commissions
 - d. Suggested interviewing retiring vestry members & officers about their experiences with the Vestry & Commissions
 - Interviews should be conducted prior to the Vestry Retreat
 - ii. Develop set of questions to be asked at each interview
 - e. Ellen Collins, Deanna Soulis & Bob Ayrer offered to revise the Commission structure and Vestry liaison's responsibilities and present at a future Vestry meeting or the Vestry Retreat
