- I. Meeting called to order at 7:00pm
 - a. Pursuant to the authority MD Code Corporations & Associations Section 2-409(d), the Vestry held a meeting in which the people listed above participated.
 - b. Sr. Warden Bob Speelman declared a quorum had been reached. The meeting was called to order.
 - c. The Vestry members could hear all others participating in the telephonic meeting.
 - d. Each person had an opportunity to express opinions on the subjects discussed and to cast a vote on motions.
 - e. Prayers were read from pages 117-126 of the BCP
 - f. Scripture passage was read by Sue Ellen Spotts from Luke chapter 18 35:42. A brief discussion of the man's faith ensued. Fr. Todd referred to this past Wednesday's word with the parallel that people do not always see the person on the inside.
 - g. A motion was made by Deanna Soulis and seconded by Evvie Williams to approve the minutes of May 25.

II. Reports

- a. Treasurer Katherine Foreman report submitted as printed and archived
 - i. Katherine added that the cash flow is running short. She had to pull \$4,500.00 to meet cash requirements. The expenses are higher than the cash flow. Fr. Todd asked what utility expenses are higher. Katherine responded expenses are going up because of extra fuel charges. An additional \$30,000.00 from the Maletzky estate will be placed in the Maletzky fund.
- b. Rector Fr. Todd Young report submitted as printed and archived
 - i. The best day for St. John's Day to be held is September 18, the third Sunday in September.
 - ii. Fr. Todd was sad to report that he had to give a No Trespass letter to an "overnight guest" who camps out behind the sign on the premises. Cindy Messersmith told Fr. Todd of a service *Greenline Security* that provides security for this type of problem. Fr. Todd asked for a show of hands from the Vestry if they would like to pursue information for this type of security. After receiving a "Yes" vote the intent to pursue additional information is sent on to Fabric and Grounds.
- c. Sr. Warden Bob Speelman report submitted as printed and archived
 - i. Sr. Warden Bob Speelman received a letter from Bill Soulis about the St. John's Shelter. The letter thanked Bruce and his partners for funds donated to them from their cheesecake sale.
- d. Jr. Warden report submitted as printed and archived.
 - i. Jr. Warden Deanna Soulis tells the Vestry they are in the final stages of planning for Pride Day. It will be held from noon to 5 p.m. They have 3 different decals of stickers. On the back of the stickers are times of our services and the address of our website.
 - ii. The Vestry picnic will be held July 23 at the home of Bill and Deanna Soulis. The picnic will be held rain or shine. Deanna asks everyone to sign up by July 8 to let her know what they will bring. Entre' for the picnic is marinated BBQ chicken. Iced tea, lemonade, water, red and white wine will also be served.

 - i. Deacon Sue says there are boxes in the parish hall that appear to be clothing. She asks the Vestry if anyone knows what they are. Fr. Todd said he will place this request in E-Tidings.

- g. Strategic planning Bruce Massey report submitted as printed and archived.

i. Bruce Massey told the Vestry there will be an interim report from strategic planning to Fr. Todd by July 7. Also, there is to be an interim meeting of the Vestry regarding strategic planning on July 10. Bruce asks to be e-mailed to inform him of attendance to this meeting ASAP.

They are allowing her into discernment with the Diocesan Committee on Ministry to explore her call to ministry. The Vestry is to encourage Kelly with prayer and get to know her. St. John's can contribute funds to this process if they like. Fr. Todd adds that since this is a 2-year process he hopes Kelly will become more visible to the parish with home visits, taking communion to shut-ins, etc.
 - ii. Vestry member Evvie Williams expressed her favor of supporting "opening the door" for Kelly.
 - iii. A motion and a second were made to recommend Kelly.
