**CCS STATEMENT OF FAITH**

**GOD.** We believe that there is only one true, living and eternal God and that the Godhead is revealed as Father, Son and Holy Spirit.

**THE BIBLE.** We believe that the Holy Scriptures are the Old and New Testaments; the inspired and infallible Word of God and therein is found the only reliable guide of a Disciple's faith and conduct.
