The headlines of today foretell the challenges of tomorrow. Religious liberty in America is under attack as never before. On June 26, 2013, the United States Supreme Court struck down the provision of the Defense of Marriage Act that defines marriage as a union between one man and one woman.

The New Mexico Supreme Court has upheld a fine assessed against a Christian photographer who declined to photograph a commitment ceremony between members of a same-sex couple.

Atheists have sued the IRS—so far, successfully— alleging that the agency is failing adequately to curb so- called political activity by churches.

A federal judge in Massachusetts has allowed a Ugandan gay rights group to pursue a claim against a U.S. pastor for speaking in favor of the biblical position regarding homosexuality.
