

**MEDI-AID CENTRE FOUNDATION LIMITED
CRITERION FOR APPLICANTS:-**

Just briefly:-

Medi-Aid is a privately run non-profit organisation which is audited by the Government.

Applicants.....

- 1. must be 60 years old and over;**
- 2. must be on a Centrelink pension;**
- 3. are not permitted to own any real estate;**
- 4. must not have much in the way of assets;**
- 5. are not permitted to be employed;**
- 6. must be able to take care of themselves without the assistance of a carer.**

All accommodation on offer is.....

- 1. in highrise apartments in the middle of Surfers Paradise;**
- 2. all are leased on an unfurnished basis, but some have bits and pieces of furniture;**
- 3. single people will only be offered a 1 bedroom or studio unit. Two bedrooms are offered to couples only;**
- 4. held under the terms and conditions of a standard lease document, bond equivalent to 4 weeks is payable and rental must be paid fortnightly in advance.**

Applicants are cautioned that.....

- 1. whilst the accommodation offers a wonderful life style with views of the ocean and beach, close proximity to transport and shopping, security and**

the convenience of lifts instead of stairs, they are in the centre of the "Tourist Capital of Australia" AND IT CAN BE VERY NOISY during the Car Racing week and Schoolies week, and of course, holiday periods.

To apply.....

- 1. either call into our office at Shop 1, 38-40 Thomas Drive, Chevron Island, pick up an application form (or download one from our website), take it away, and complete it in full, providing all documents required INCLUDING a detailed and confidential letter setting out your circumstances to show you are eligible for this type of assistance. We also require a Centrelink Income Statement for each person applying.**
- 2. Once these details are collated, telephone our office and make an appointment for an interview.**
- 3. We will conduct the interview and then send a recommendation for approval or otherwise to Medi-Aid.**
- 4. If you are approved, then you will be placed on a waiting list - unfortunately, we are not able to estimate the length of time you may have to wait.**

We look forward to your telephone call to arrange a mutually suitable interview time.

SUBSIDISED ACCOMMODATION AT SURFERS PARADISE

Thank you for your recent enquiry regarding accommodation at Surfers Paradise.

Medi-Aid Centre Foundation is a Sydney-based non-profit Public Benevolent Institution which assists people 60 years and older with accommodation problems. It now operates in Surfers Paradise. We are a private organisation, not related to any church, political or community operation and receive no government assistance.

Rentals to eligible persons are at a discount to the market price for the type of accommodation offered. Requirements are that the individual is 60 years or older, does not own a house or any real estate, is not employed, and has a housing problem. Rent is payable calendar monthly in advance. A four-week rental bond is also required and the standard General Tenancy Agreement Form 18a must be signed. The accommodation is a home unit in Surfers Paradise close to the surf, beach or the river.

The attached application form must be completed along with a **detailed letter setting out your circumstances (which clearly states that you DO NOT own any real estate)** and why you should receive this type of assisted accommodation. This material is kept confidential.

When you have all the documentation required call Ocean Blue Realty and make an appointment for an interview with George Georgiou.

AN INTERVIEW CANNOT BE GRANTED WITHOUT A PRIOR APPOINTMENT. Please bring all documents with you at that time.

1. We have been informed, understand and agree that the rental for the said property is to be paid every Fortnight and is to be paid by the due date at all times. We understand that the agent will conduct regular inspections of the property and we further warrant that I will cooperate fully to allow these inspections to occur. If we cannot be at home at the time of the scheduled inspection, we agree that the agent will enter the property using the office keys.
2. We have been informed, understand and agree that the Bond required for any property will be 4 X the rent and we further authorise the agent to attend to all details regarding the lodgement of the said Bond with the appropriate authority.
3. We have been informed, understand and agree that the acceptance of this application is subject to a satisfactory report being obtained from the information supplied on the fully completed application submitted by us. We further consent to the agent carrying out any enquires to process this application.
4. We have been informed, understand and agree that should there be a requirement to commence proceedings for recovery of rent, repairs or damage to the aforesaid property, all costs of recovery in respect of these proceedings shall be able to be recovered from us.
5. **NOTE TO APPLICANTS
MEDI-AID CENTRE FOUNDATION LIMITED ACCOMMODATION**

We just need to draw your attention to some very important guidelines you need to follow when writing the detailed letter required to accompany your application form.

It is important that you use these guidelines when composing your letter to Medi-Aid Centre Foundation Limited, and we hope this will simplify the process.

In this letter you must: -

1. State your age;
2. List any assets you may have (remember, you are not permitted to own any real estate-this will disqualify you from eligibility);
3. State clearly that you are suffering under “financial hardship” and set out in detail the reasons for this financial hardship – remember, this is the most important aspect of your application. Please use the words ***'financial hardship'*** in your letter.
4. You may mention any medical problems you have, however, please be brief as this is not to be the focus of your letter and it is important that Medi-Aid are assured that you can take care of yourself and the property without assistance.

PLEASE NOTE: It is imperative that you supply your Centrelink Income Statement with your Application.
