ABOUT THE EAST COAST MUSIC AWARDS

The East Coast Music Association (ECMA) presents up to 50 awards each year. Winners are chosen entirely by a jury panel consisting of qualified regional, national and international industry professionals. Voting for the Fans' Choice Awards (Entertainer of the Year and Video of the Year) are open to a public vote.

SUBMISSION GUIDELINES

- A minimum of four (4) submissions per category is required for an award to be presented for the jury process. NOTE: If there are fewer than the minimum required submissions in a given category, it will be carried over to the following year once. A recording may only be carried over to a following year one time.
- ECMA reserves the right to disqualify any applications that do not meet ECMA's Eligibility/Screening Criteria.

 Disqualified or unaccepted submissions will not be notified.
- All submission requirements must be met. Incomplete or late applications will not be accepted.
- Any occurrences of questionable eligibility shall be dealt with at the discretion of the ECMA Awards & Stages Committee.

ELIGIBILITY TIME PERIODS

<u>Music Award Eligibility Period (except for the six categories listed below):</u>

June 1, 2020 - October 8, 2021

Alternate eligibility periods apply to the following:

African Canadian Artist of the Year Eligibility Period:

June 1, 2019 - October 8, 2021

Blues Recording of the Year Eligibility Period:

June 1, 2019 - October 8, 2021

Children's Entertainer of the Year Eligibility Period:

June 1, 2019 - October 8, 2021

Indigenous Artist of the Year Eligibility Period:

June 1, 2019 - October 8, 2021

R&B/Soul Recording of the Year Eligibility Period:

June 1, 2019 - October 8, 2021

Global Music Recording of the Year Eligibility Period:

June 1, 2019 - October 8, 2021

Recording(s) must be released within the eligibility period outlined.

Pre-orders: Recordings will also qualify if they are available for pre-order online no later than October 8, 2021. Pre-ordered recordings (digital and/or physical copies) must be available by December 31, 2021. ECMA may request proof of transaction.

BASIC SCREENING REQUIREMENTS

- Must be Atlantic Canadian (please see terms and definitions section for more information)
- · Must be an ECMA Member in good standing
- Must only submit for one genre-specific category for each "recording"
- The same recording must not be nominated more than once in the same category, if it was submitted in a previous year and still falls within the eligibility period
- Recording(s) must be commercially released within the eligibility period outlined
- · Requires a full length recording (min 5 tracks or 15 mins).

EXCEPT for (please see the category specific eligibility requirements for more information on recording requirements):

- · Classical Composer of the Year
- · Dance Recording of the Year

Please note: Eligible singles for submission are limited to one recording submission per category for consideration per applicant/artist.

- 50% of the release must be of previously unreleased cuts
- Must have proof of release date from a distributor, manufacturing invoice, and/or a record company, OR show proof that the release is available through three (3) alternate sources of professional distribution (please see recording requirements for more information)
- · Must meet award category eligibility requirements

CATEGORY EXCEPTIONS TO BASIC SCREENING REQUIREMENTS:

Fans' Choice Entertainer of the Year:

- Open to **ALL** Atlantic Canadian Artists, regardless of eligible releases
- Must be an ECMA Member in good standing
- Must meet eligibility requirements of this category

Fans' Choice Video of the Year:

- Must be Atlantic Canadian (please see definition in manual)
- Must be an ECMA Member in good standing
- The same video must not be nominated more than once in the same category, if it was submitted a previous year and still falls within the eligibility period
- Video(s) must be released within the eligibility period
- Must meet eligibility requirements of this category

RECORDING REQUIREMENTS

- Submissions, except where indicated, require a full-length recording. A full-length recording is defined as a recording that contains a minimum of five (5) tracks, or is a minimum of 15 minutes long. At least (50%) of the tracks on a recording must be of previously unreleased cuts. A "cut" is defined as recorded material previously released to radio or other audio broadcasters (web, satellite, and digital) or retail.
- All manufactured product must meet industry standards and be available for sale through live performances or retail stores that sell sound recordings in the ordinary course of business, internet sales or streaming, or mail orders.
- The artist/group will be asked to provide proof of release date. This can be done through providing manufacturing invoices, a letter from a distributor, and/or a record company. In lieu of proof from a manufacturer, distributor or record company, the artist/group may provide documentation confirming that product is available through three (3) alternate sources of professional distribution (e.g. letter from retailer, contract with internet point of sale, catalogue listing, DSP (digital service provider), such as Apple Music/iTunes, etc.) as well as web or print announcements of the release date.
- Recordings must fulfill all legal obligations (i.e. payment of mechanical rights, songwriting credits, etc.).
- Artist/Group is responsible to ensure that any music samples, video clips or other audio and/or visual materials contained in any recording, video or other materials that form part of your submission are fully authorized by master rights owners, music publishers and any other third parties that have rights in such materials. ECMA reserves the right to require written confirmation that these rights have been secured. ECMA reserves the right to disqualify submissions, nominees or winners should ECMA determine, in its sole discretion, that these rights have not been secured.

DEADLINES:

All submissions will be accepted until October 8th at 11:59 PM (ADT) / Invoice Payment Deadline: Due upon receipt All submission requirements must be met. Incomplete or late applications will not be accepted. Please ensure you give yourself enough time to complete and submit your application!

SUBMISSION PROCESS

All submissions will be accepted until October 8, 2021 by 11:59 PM ADT on ecma.awardstage.com.

- 1. All submission requirements must be met. Incomplete or late applications will not be accepted.
- 2. Following submissions and jurying, nominees will be announced at the ECMA 2022 Press Conference (date to be determined).
 - Note: The Fans' Choice Entertainer of the Year and Fans' Choice Video of the Year categories will be opened to a public vote following the ECMA Press Conference.
- 3. Winners are announced at the East Coast Music Awards: Festival & Conference.

Any occurrences of questionable eligibility shall be dealt with at the discretion of the ECMA Awards & Stages Committee.

SUBMISSION PRICING

All music award submissions cost \$20 CAD with the exception, of the following categories.

It is FREE to submit to:

- African Canadian Artist of the Year
- · Indigenous Artist of the Year
- All Industry Awards
- All Honourary Awards

NOTE: Applicants must be ECMA members in good standing, and will be invoiced directly from ECMA if membership is not in good standing. Application fees are non-refundable for award categories.

JURYING PROCESS

All East Coast Music Awards & Showcases are fully juried by qualified regional, national, and international industry professionals. Jury Members evaluate applications, and score based on a set criteria / rubric (please see jury criteria section for more information).

- After being juried, the nominees are chosen based on the 5 highest-scoring submissions per category. In the case of a tie, there may be more than five (5) nominees per category.
- ECMA has 2 Fans' Choice categories that are voted on by the public. These awards are first submitted for jurying and then shared with the public for voting.
 - NOTE: No other awards are submitted for voting.
- To be considered for awards and showcasing, an application must be submitted through the official application process.

MEMBERSHIP FEE (IF APPLICABLE)

Payment is due upon receipt of invoice. If you do not make your payment by the deadline, your application will be forfeited and will not be sent to jury.

Please expect an invoice to be sent to your contact information email provided in the application if your membership is not in good standing, via finance@ecma.com. Payment is due upon receipt of invoice.

Who is this awarded to: Artist/Group Minimum Criteria:

- · Recognizes all music genres.
- This award does not require a full-length release, but the artist/group must submit at least three (3) songs released within the following dates:
 June 1, 2019 October 8, 2021.
- If a group, the majority of the core members must be African-Canadian and fulfill the eligibility criteria, as determined by our African Canadian Sub-Committee of the board
- Must meet all basic screening requirements (please see screening requirements section).

Eligible submissions, as determined by our partner African-Canadian committee, will be evaluated by a jury of Black artists and/or music industry professionals from the East Coast, Canada, or abroad.

What does this Award Recognize: The recordings and industry achievements by an African-Canadian artist or group in any genre.

CLASSICAL COMPOSER OF THE YEAR

Who is this awarded to: The composer Minimum Criteria:

- The composer must be Atlantic Canadian; for collaborations or groups, at least 50% of the composers must fulfill the eligibility criteria. It is not necessary that the songs submitted be recorded by an Atlantic Canadian artist or group.
- Only one composition per composer may be submitted per year.
- Includes all original Atlantic Canadian classical works composed within the last fifty years and recorded within the eligibility period.
- Does not require a full-length recording for eligibility.
- Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize:

A recording of a composition

INSTRUMENTAL RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- At least 75% of the tracks must be without lyrics
- May represent all genres and styles of music with traditional musical arrangements (i.e. using traditional instruments).
- Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize: The recordings

Additional Notes: Artists using synthesizers, looping, etc. should consider submitting to our Dance Recording of the year or Electronic Recording of the Year categories.

What does this Award Recognize: The recordings and vocal performance

Additional Notes: Francophone artists are invited to submit to any other eligible categories that may suit them.

INDIGENOUS ARTIST OF THE YEAR

Free to submit!

Who is this awarded to: Artist/Group

Minimum Criteria:

- If a group, majority of the core members must be Indigenous and fulfill the eligibility criteria as determined by our Indigenous Sub-Committee of the board.
- This award does not require a full-length release, but the artist/group must submit at least three (3) songs released within the following dates:
 June 1, 2019 October 8, 2021.
- Must meet all basic screening requirements (please see screening requirements section).

Eligible submissions, as determined by our Indigenous sub-committee of the board, will be evaluated by a jury of Indigenous artists and/or music industry professionals from the East Coast and Canada.

What does this Award Recognize: The recordings, industry achievements, and music encompassing a wide variety of musical genres created by First Nations, Inuit. and Métis artists.

MUSIC AWARD CATEGORIES

FANS' CHOICE CATEGORIES

A single award is presented in each category except in the event of a tie. Artists/groups may submit for one or both of the Fans' Choice categories (if criteria is met, separate fees apply). Nominees are chosen by a panel of jurors and winners are selected by public vote.

FANS' CHOICE VIDEO OF THE YEAR

Who is this awarded to: Artist/Group and Director

Minimum Criteria:

Must meet two (2) of the following criteria:

- 1. Substantial amount of video plays (over 5,000 views on at least one video, and cumulative exceeding 7,500 views on all videos)
- 2. Social media following of at least 5,000 followers on all platforms combined
- 3. Must have had either (NOTE: In light of COVID-19, this criteria has been adjusted):
 - a. A minimum of one international tour and/or national tour within the eligibility period;
 - b. A cancelled international/national tour, due to COVID-19, that was scheduled during the eligibility period (must provide proof of scheduled dates); or
 - c. Virtual shows that were booked with national and/or international reach during the eligibility period (you will be required to provide sufficient supporting documentation)
- 4. Media coverage that is national in scope within the eligibility period

In addition to the criteria above, you MUST meet certain screening requirements (please see screening section). This category is an exception to some requirements listed and is noted in the screening section accordingly.

What does this Award Recognize: A music video released to television or other broadcasters, or officially launched online during the eligibility period.



FANS' CHOICE ENTERTAINER OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

Must meet two (2) of the following criteria:

- Substantial amount of video plays (over 5,000 views on at least one video, and cumulative exceeding 7,500 views on all videos)
- 2. Social media following of at least 5,000 followers on all platforms combined
- 3. Must have had either (NOTE: In light of COVID-19, this criteria has been adjusted):
 - a. A minimum of one international tour and/or national tour within the eligibility period;
 - b. A cancelled international/national tour, due to COVID-19, that was scheduled during the eligibility period (must provide proof of scheduled dates); or
 - c. Virtual shows that were booked with national and/or international reach during the eligibility period (you will be required to provide sufficient supporting documentation)
- 4. Media coverage that is national in scope within the eligibility period

- 1. Substantial amount of video plays (over 5,000 views on at least one video, and cumulative exceeding 7,500 views on all videos)
- 2. Social media following of at least 5,000 followers on all platforms combined
- 3. Must have had either (NOTE: In light of COVID-19, this criteria has been adjusted):
 - a. A minimum of one international tour and/or national tour within the eligibility period;
 - b. A cancelled international/national tour, due to COVID-19, that was scheduled during the eligibility period (must provide proof of scheduled dates); or

- 2. Social media following of at least 5,000 followers on all platforms combined
- 3. Must have had either (NOTE: In light of COVID-19, this criteria has been adjusted):
 - a. A minimum of one international tour and/or national tour within the eligibility period;
 - b. A cancelled international/national tour, due to COVID-19, that was scheduled during the eligibility period (must provide proof of scheduled dates); or
 - c. Virtual shows that were booked with national and/or international reach during the eligibility period (you will be required to provide sufficient supporting documentation)
- 4. Media coverage that is national in scope within the eligibility period

- 1. Substantial amount of video plays (over 5,000 views on at least one video, and cumulative exceeding 7,500 views on all videos)
- 2. Social media following of at least 5,000 followers on all platforms combined
- 3. Must have had either (NOTE: In light of COVID-19, this criteria has been adjusted):
 - a. A minimum of one international tour and/or national tour within the eligibility period;
 - b. A cancelled international/national tour, due to COVID-19, that was scheduled during the eligibility period (must provide proof of scheduled dates); or
 - c. Virtual shows that were booked with national and/or international reach during the eligibility period (you will be required to provide sufficient supporting documentation)
- 4. Media coverage that is national in scope within the eligibility period

- 2. Social media following of at least 5,000 followers on all platforms combined
- 3. Must have had either (NOTE: In light of COVID-19, this criteria has been adjusted):
 - a. A minimum of one international tour and/or national tour within the eligibility period;
 - b. A cancelled international/national tour, due to COVID-19, that was scheduled during the eligibility period (must provide proof of scheduled dates); or
 - c. Virtual shows that were booked with national and/or international reach during the eligibility period (you will be required to provide sufficient supporting documentation)
- 4. Media coverage that is national in scope within the eligibility period

SONG OF THE YEAR

Who is this awarded to: Artist/Group and the Producer

<u>Minimum Criteria</u>: Met through a combination of any two (2) of the following criteria listed below, unless otherwise noted:

- 1. Substantial amount of video plays (over 5,000 views on at least one video, and cumulative exceeding 7,500 views on all videos)
- 2. Social media following of at least 5,000 followers on all platforms combined
- 3. Must have had either (NOTE: In light of COVID-19, this criteria has been adjusted):
 - a. A minimum of one international tour and/or national tour within the eligibility period;
 - b. A cancelled international/national tour, due to COVID-19, that was scheduled during the eligibility period (must provide proof of scheduled dates); or
 - c. Virtual shows that were booked with national and/or international reach during the eligibility period (you will be required to provide sufficient supporting documentation)
- 4. Media coverage that is national in scope within the eligibility period

Who is this awarded to: The Songwriter

Minimum Criteria:

- 1. Media coverage that is national in scope within the eligibility period
- 2. Must submit a collection of three or more songs; Does not require a full-length recording for eligibility.

In addition, you MUST meet all basic screening requirements (please see screening section).

What does this Award Recognize: The recordings and excellence in the lyrics and melody based on a collection of three or more songs.

Additional Notes:

- The songwriter must be Atlantic Canadian. It is not necessary that the songs submitted be recorded by an Atlantic Canadian artist or group
- On collaborative work, at least one of the songwriters must meet all ECMA eligibility criteria.
- It is not necessary for the songwriter to also be the performer of the songs
- The songwriter can submit songs performed by the same artist/ group or a collection of songs performed by various artists, as long as all the songs submitted were released within the eligibility period

<u>Jury criteria note</u>: Jurors are asked to base their scores on the success of the songs themselves when scoring the 'Accomplishments & Brand' section



GENRE-SPECIFIC CATEGORIES

A single award is presented in each category, unless in the event of a tie. Artists/groups may only submit for one (1) genre-specific category.

BLUES RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- All styles of blues qualify for this award (e.g. Country, Chicago, Delta, East Coast, etc.)
- Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize: The recordings

CHILDREN'S ENTERTAINER OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- Children's Recordings must include repertoire suitable and obviously directed to a young listening audience.
- Material must be musical in nature or contain musical elements (ex: narratives or dramatic recordings must contain music).
- If a group, at least 50% of the members must fulfill the eligibility criteria.
- Must meet all basic screening requirements (please see screening requirements section).
- Material must be released within the following dates: June 1, 2019 - October 8, 2021.

<u>What does this Award Recognize</u>: The recordings and the Artist/Group

CLASSICAL RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- Can be instrumental or vocal.
- This category includes: soloists, chamber ensembles, instrumental ensembles, instrumental soloists with large ensemble or chamber ensemble accompaniment
- Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize: The recordings

CONTEMPORARY ROOTS RECORDING OF THE YEAR

Who is this awarded to: Artist/group

Minimum Criteria:

- · At least 75% of the tracks must be vocal
- Recently composed vocal or instrumental contemporary material
- Must be influenced by roots music styles and incorporates new sounds (electric or otherwise)/instrumentation (ie. from more than one culture, roots, genre, or otherwise) to create music that is distanced from the Roots / Traditional music category
- Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize: The recordings

<u>Additional Notes:</u> If you choose to apply for any genre-specific category, you are not eligible to apply to any other genre-specific award categories (please see list of other genre-specific categories).

COUNTRY RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- · Recognizes all styles of country music including Alt-country, Traditional country, Western swing, etc.
- · Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize: The recordings

DANCE RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

This category recognizes club-oriented dance mixes in various subgenres including, but not limited to: NRG, EDM, House, Techno, Garage, Euro-beat, Miami Sound, Latin Freestyle, Hip-House, and Nu-Disco.

To be eligible, a submission must satisfy one or more of the following indicators:

- 1. Product is available for sale either online or through traditional retail stores, which sell sound recordings in the ordinary course of business. Exception: promo-only and DJ-only singles released during the eligibility period are eligible.
- 2. Promotion singles are also eligible if they have received airplay on one or more of the nationally recognized commercial radio stations.
- 3. The single has charted on a weekly club or radio chart.
- 4. The single was charted or playlisted on one of the officially recognized dance pools, DJ playlists/DJ Set, or zip DJ.

In addition, you MUST meet all basic screening requirements (please see screening section).

What does this Award Recognize: Singles, EPs or full-length recordings (please see criteria and additional notes for further detail)

Additional Notes:

- If a recording is nominated one year, it may NOT be resubmitted the following year using different "listening" cuts
- · Only one single per artist may be submitted per year
- · Submissions in either the original mix or a remix will be accepted
- The artist/group must indicate the specific submission where more than one mix, extension, or remix exists
- Dance remixes of other genres/styles of music are NOT eligible. Exception: if a dance version and non-dance version of the same recording are released simultaneously, i.e. the album release includes both recording versions.
- The artist listing may include the acronyms "vs" "&" or "featuring," however, at least 50% of the members must fulfill the eligibility criteria (Screening requirements). Sampled vocals/music is not factored into this equation.

ELECTRONIC RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

This category recognizes electronic music in various subgenres including, but not limited to:Ambient, Electro-pop, Noise, Experimental, Grime, Dub, etc.

Minimum Criteria:

- An artist/group that employs electronic musical instruments and electronic music technology at the root of its production.
- · This category recognizes EPs or full-length recordings
- Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize: EP's or full-length recordings released to radio or other audio broadcasters (web, satellite, digital) or on a multi-track/multi-artist compilation of new material during the eligibility period.

Additional Notes: If you choose to apply for any genre-specific category, you are not eligible to apply to any other genre-specific award categories (please see list of other genre-specific categories).

FOLK RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- At least 75% of the tracks must be vocal
- Recognizes acoustic-based, contemporary material that represents the musical expression of the performer(s)
- Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize: The recordings

GLOBAL MUSIC RECORDING OF THE YEAR

New!

Who is this awarded to: Artist/Group

Minimum Criteria:

 Recognizes all global music recordings including, but not limited to, roots based or cross-cultural music incorporating diverse styles from Africa, Europe, Asia, South and Central America, the Caribbean (including Reggae), the Middle East, Oceania, and nonmainstream Western folk sources. This definition excludes New Age music. Majority of the recording must be categorized as Global Music. If an album can be classified primarily in another genre, the album will not be eligible for the Global Music Recording of the Year category.

- Must meet all basic screening requirements (please see screening requirements section).
- Material must be released within the following dates: June 1, 2019 - October 8, 2021.

What does this Award Recognize: The recordings

INSPIRATIONAL RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

- All styles of inspirational, traditional gospel, or contemporary religious music (eg. country, pop, rock, soul, bluegrass, classical, etc.) qualify for this award.

JAZZ RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- All styles of jazz music qualify for this award including instrumental and vocal content.

LOUD RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- This category recognizes EPs or full-length recordings
- 'Heavy' or 'loud' music, which encompasses such genres as Hardcore, Metal, Punk, or other sub-genres
- Must meet all basic screening requirements (please see screening requirements section).

Additional Notes: Only one single per artist may be submitted per year.

RAP/HIP-HOP RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- This category recognizes all music that predominantly embraces rap or hip-hop genres, as well as sub-genres.
- Must meet all basic screening requirements (please see screening requirements section).
- Does not require a full-length recording for eligibility; May submit an EP or single to qualify.

What does this Award Recognize: The recordings

Additional Notes: Only one single per artist may be submitted per year

ROCK RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- Recognizes a release by a recording artist whose music embraces the rock genre and/or sub-genres of alternative music.
- Must meet all basic screening requirements (please see screening requirements section).

What does this Award Recognize: The recordings

ROOTS / TRADITIONAL RECORDING OF THE YEAR

Who is this awarded to: Artist/Group

Minimum Criteria:

- All vocal or instrumental with original arrangements, and ethnically specific traditional music is eligible (e.g. Cajun, Celtic, Irish, Scottish, etc.)
- Must meet all basic screening requirements (please see screening requirements section).

Please note that artists will be required to provide a list of tour information (past and upcoming; eg. upcoming bookings and professionally booked livestream shows) in which must be in representation of the applicant group/artist. |
