BI Strategy Formation and Coaching

Many BI and analytics directors are too busy to create a crisp, cogent strategy and plan to present to business and technical executives. Our senior consultants work one-on-one with business analytics directors to develop a compelling business case for new investment. We work quickly and collaboratively to give shape to your vision and present it in a way that maximizes chances of adoption.

Packaging the Vision. If time is short, we can elicit your vision, refine your business analytics strategy and create a draft slide presentation and/or report that you can use as a basis for an executive presentation. The output usually includes a current state assessment and future state, along with a series of recommendations and a financial analysis of how to implement the vision. If business analytics directors clear their schedule, this can take as little as three to five working days.

Refining the Vision. If there is a longer lead time, Eckerson Group can refine or validate the strategy by interviewing key stakeholders in the business and technical teams to uncover hidden opportunities and pitfalls in the strategy.

Presenting the Vision. In addition, Eckerson Group can help business analytics directors present the strategy to executives, who are often more apt to heed the advice of an independent expert than an internal one.

BI Assessment and Roadmap Services


Eckerson Group takes a holistic approach to assessing BI and analytics programs and creating roadmaps. We not only dive into technology and architecture, but we focus on the people, processes, and organizational models required to reap tangible value from information investments.

Specifically, we look at five architectures: business, organization, analytics, data and governance architectures. We work collaboratively with clients to evaluate each architecture and develop recommendations to optimize delivery.



Eckerson Group uses an agile methodology to evaluate a program's current state, define a future state, and create a roadmap to close the gap. A typical assessment delivers 8 to 12 recommendations and a financial analysis that maps out investments in staffing, infrastructure, tools, and services.

Most assessments require three days of onsite interviews and three weeks of total consulting time. Most projects span 10 to 12 weeks, finishing with an executive presentation and delivery of a 40-page report.

Data Governance and Master Data
