Successfully put 60+ students through the program in the first six months of FY17 versus 25 students for all of FY16.

Assembled and conducted advanced training for a Quick Reaction Force. Redesigned force protection procedures and exercises, including readiness and response drills for imminent attacks, active shooters, explosions and fires. Strengthened security, achieving base-wide zero-attack performance during the assignment.
