2011-2013 Chapter Key Award Criteria

Eligibility

In order to apply for the 2013 Chapter Key Award, which recognizes chapter activity for the timeframe between 1 July 2011 and 30 June 2013, chapters must have met chapter responsibilities as outlined in STTI bylaws.

According to Article IV, Section 8 of the International Bylaws, a chapter's responsibilities include:

- Supporting the purposes of the STTI
- Observing the provisions of the bylaws and complying with STTI's policies and regulations
- Participating in the biennial convention House of Delegates and other business brought forth before the House of Delegates during the term (This includes the electronic voting by delegates throughout the year. Note: In addition to the in-person vote at the November 2011 House of Delegates, electronic votes will occur in September 2011, February/March and October/November 2012 as well as February/March 2013.)
- Selecting and inducting eligible members a minimum of one time annually
- Meeting all financial obligations
 (This includes cashing chapter checks in a timely manner as they are issued to the chapter by headquarters.)
- Filing required reports according to established guidelines.
 (This includes the on-time submission of the 2011 and 2012 Chapter Annual Reports - Deadline is early August of each year.

Criteria

There are five (5) categories in which chapters can earn points. They are:

- Leadership
- Knowledge
- Service
- Community
- Sustainability

Below is a grid that outlines each of these sections and provides examples or additional comments to help guide chapters. Examples provided are merely suggested projects and other chapter activities may also be eligible for points. Chapters are encouraged to use these criteria as a reference as they plan our programs and activities for their chapter throughout the biennium.

Chapters should track their activities and record member participation throughout the biennium in order to make preparation for Chapter Key Award submission an easier process.
