PLATFORM

- 1. Full prescriptive authority with DEA credentialing for APRNs.
- 2. Full Practice Authority for APRNs, allowing practice to the fullest extent of their education and training
- 3. Authorize APRNs to sign Baker Acts.
- 4. Authorize APRNs to determine Maximum Medical Improvement and Permanent Impairment Rating for workers' compensation claims.
- 5. Authorize APRNs to prescribe home health and hospice care.
- 6. Empanelment of APRNs to all third-party payers for full scope of practice services.
- 7. Authorize APRNs to sign death certificates.
- 8. Authorize APRNs to sign fetal demise and birth certificates.
- 9. Define APRNs as Licensed Health Professionals to sign all designated health forms.
- 10. Designate APRNs as Medicaid PCPs.
- 11. Full reimbursement for APRNs under Medicare/Medicaid repayment.
- 12. Designate APRNs to act as directors for Florida Health Care Homes.
- 13. Place all control of Florida APRNs, RNs, and LPNs solely under the
- auspices and control of the Florida Board of Nursing. Remove all aspects of professional nursing practice regulation from any other authority agency of government.
- 14. Adopt the National Council of State Boards of Nursing consensus model for APRN regulation.

JAAPRN was originally named Jacksonville Association of Nursing and Healthcare Professionals or JANHP. When House Bill (HB) 1337/Senate Bill (SB) 1594) was approved in late March 2018, the organization's name was revisited. The statewide adoption of the term "Advanced Practice Registered Nurse" or APRN in place of "Advanced Registered Nurse Practitioner" (ARNP) compelled our board members to change JANHP's name to reflect the most current term as a proactive step for our new organization, thus JANHP became JAAPRN.

JAAPRN MEETINGS RECAP

<u>January 2018:</u> Our first official meet-and-greet was held at Seven Bridges Grill and Bar, Jacksonville, on Jan 24, 2018. Our guest speaker was Stan Whittaker, MSN, NP-C, chair of <u>Florida Association of Nurse Practitioners (FLANP)</u>, who is a major proponent for NPs in the sunshine state. He introduced names of representatives and future political candidates in the Jacksonville area and discussed ways of becoming more involved in local nurse advocacy issues.

April 2018: April's meeting was held at Chamberlain College of Nursing, with many thanks to the Jacksonville Campus President, <u>Dr. Beverly Bonaparte</u>. 


The AANP 2018 National Conference was held June 26-July 1 in Denver at the Colorado Convention Center.
