Purpose of Award:	The award is intended to provide financial support to an e- Chapter member to attend the annual NAPNAP Conference.
Description:	
 What the award will be honoring or distinguishing 	The award will be given to an e-Chapter member who does not receive any other type of financial support to attend the annual national NAPNAP Conference.
• Timeline	Deadline to submit the application will be October 31 st annually.
Award amount	Maximum: Cost of annual conference registration
Funding source	e-Chapter
 How often a member can apply for or receive award 	Members can apply annually, but they may only receive the award one time in three years. The award cannot be carried over to another year.
• Requirements	 The member must be an active member of NAPNAP and the e-Chapter for a minimum of one full year and not receive financial support to attend the national conference from any other source (employment, SIG, grant or scholarship, or other funding sources). Recipient must pay their own conference registration and will be reimbursed within 30 days following the annual NAPNAP conference. Scholarship recipient must attend the annual e-Chapter meeting at the annual conference. Scholarship recipient will be required to serve a two-year term as a volunteer on an e-Chapter committee.
Other stipulations requested	A minimum of at least two applicants is required and the winner must score a minimum of 15 points for the award to

	be given. If the minimum number of applications are not received or the applicants do not meet the qualifications for the award, no funding will be distributed for the year.
Submission deadlines	October 31 st annually
Award Announcement	December 1
Marketing plan for award	Information will be posted on the NAPNAP e-Chapter site and on the ENP e-Chapter website. e-Chapter membership will receive an email about the award and application process.
Criteria for Qualification:	
Membership status or open to non-members	Must be an active member of e-Chapter. This scholarship is not open to NAPNAP members who are not members of the e-Chapter. e-Chapter Board members are not eligible.
Minimum membership timeframe	One full calendar year as e-Chapter member prior to application.
Required letters of support	None

 Other qualifications to be considered 	Must attend national conference from Day 1 (not preconference) to closing session.

Required personal statement *	Letter written as an application to the e-Chapter officers identifying why the member is applying for the award and their plans to use the information learned at the conference to further their care for pediatric patients.
Required participation statements *	 I agree to participate in the e-chapter as a committee member for two years after receiving this award. I agree to attend national conference from Day 1 (not pre-conference) to closing session.
