Upcoming Florida Legislation

On February 12th, SB 972 was filed by Senator Jeff Brandes and would enable Advanced Practice Registered Nurses (APRNs) to practice autonomously after meeting certain requirements. APRNs may also choose to continue to practice under the current protocol arrangement. This bill is a joint effort of the Florida Coalition of Advanced Practice Nurses (FLCAPN) and the National Council of State Boards of Nursing(NCSBN).

SB 972: Innovation in the Advanced Practice Registered Nursing Workforce GENERAL BILL by Brandes

Innovation in the Advanced Practice Registered Nursing Workforce; Revising the definition of the term "advanced or specialized nursing practice" to expand the scope of practice; authorizing an advanced practice registered nurse to perform certain functions and acts within his or her specialty without a protocol agreement or

supervision if specified requirements are met; authorizing a qualified advanced practice registered nurse to admit, manage care for, and discharge certain patients and to provide an endorsement that is otherwise required to be provided by a physician, etc.

Georgia Lawmakers May Further Restrict APRN Scope of Practice

Georgia NP Imaging Bill Takes Problematic
Amendment

Senate Bill 109 took additional amendments in committee last week that would require APRNs to be licensed for five years before a physician could delegate the authority to order radiographic imaging tests in other than life-threatening situations. Patients and health care systems in Georgia are already disenfranchised from timely diagnostic care that 49 states, D.C. and the U.S. territories already authorize NPs to order at the point of initial licensure. This weighty amendment adds more unnecessary red tape. The House companion was heard in committee last week but received no vote. House Bill 409 retains the original language to lift the emergency restriction without requiring years in practice prior to physician delegation and updates Georgia's APRN/physician ratio requirements. AANP continues to evaluate the Georgia landscape around these issues.
