## CANCELLATION & REFUND POLICIES

**Cancellations/REFUNDS:** All cancellations require written notification to AMNP at [amnp.edu@gmail.com](mailto:amnp.edu@gmail.com). Each activity will specify the required time for cancellation to occur for the participant to receive a percent of refund of CE activity fees. In general, barring special circumstances: 30 day notice of cancellation yields a 10% refund. 45 day notice yields a 75% refund. 90 day notice yields a 90% refund. Any cancellations with less than 30 days' notice, without approved extenuating circumstances, will receive no refund. AMNP is not responsible for cancelling room, travel or meal plans should a participant cancel their participation. Participants who no show for CE activities will receive no refund.
