ACHIEVEMENT

"Loretta C. Ford, Co-founder of Nurse Practitioner Profession, receives US Surgeon General's Medallion for contributions to nation's health".

The Medallion, the highest honor granted to a civilian by the Public Health Service and the US Public Health Service Commissioned Corps, is awarded by the Surgeon General for actions of exceptional achievement t the cause of public health and medicine.

Legislation:

Nurse Practitioners who are issued a licensed to practice autonomously/independently, must engage in such practice only in primary practice, including family medicine, general pediatrics, and general internal medicine, as defined by board rule. (NO OTHER SPECIALTIES) Once the APRN license of independent practice is successfully issued, the NP is granted signature authority which includes the Baker Act involuntary examination, signing death certificates, admitting/discharging patients from a facility and "provide a signature, certification, stamp, verification, affidavit, or endorsement that is otherwise required by law to be provided by a physician (except for medical cannabis). This is known as signature authority.

INSIGHTS

"This pandemic has taught us the critical importance of having more nurses in leadership positions".
