

# CTC and Me - How the <u>Care</u> <u>Transformation Collaborative</u> is being endorsed by NPARI

"The mission of CTC-RI is to support the continuing transformation of primary care in Rhode Island as the foundation of an everimproving integrated, accessible, affordable, and equitable health care system. CTC-RI brings together critical stakeholders to implement, evaluate and spread effective multi-payer models to deliver, pay for and sustain high-quality, comprehensive, accountable primary care."

So, what does that mean? The CTC encompasses all primary care providers (NP, PA, MD, DO). This organization is working to help Rhode Islanders gain access to getting primary care. Primary care providers are tough to come by, therefore, one of the efforts the CTC has launched includes a tax credit proposal (like what we had previously introduced for NPs) but specific to anyone working in primary care OR taking primary care students. CTC as an organization with multiple degrees involved, this increases a strength in numbers and addresses multiple problems at once. NPARI endorses their mission for primary care access and incentive for primary care provider training.


