

Specifications: Minimum bleed of 1/8 on three (3) sides for a full page. Supply a CMYK file either as a jpeg, tiff, or pdf. If pdf, make sure it is a high-resolution pdf for print with fonts and graphics embedded. The printer can also take native application (ie InDesign, Quark, Photoshop) file with final graphics and fonts linked.

Make sure you have a CMYK (not RGB) file.

Exhibition Terms & Conditions

United Advance Practice Registered Nurses (UAPRN) has the sole discretion to place Exhibitors on the Exhibition floor and make space assignment changes prior to the Exhibition opening as it may become necessary to be consistent with good Exhibition management procedures. The exhibitor agrees to pay the amount set out in the Application for use of the Exhibit Space. It is understood that the Exhibit Space provided to the Exhibitor shall be one of many exhibit spaces comprising a given exhibition. UAPRN reserves the right to not accept applications from exhibitors, it deems inconsistent with the mission of the UAPRN or its Annual Conference.

The Exhibitor accepts total responsibility for his/her Exhibit and its safety and agrees to conduct his/her activities on the exhibition premises so as not to endanger any person lawfully thereon. UAPRN shall have no responsibility for damage to the Exhibit caused by fire, robbery, accident, or any other destructive cause. Exhibitor also accepts total responsibility for any and all injuries to Exhibitor, his/her family, officers, agents, employees or other representatives while they are on the exhibition premises and for any injuries to other persons that may occur within the confines of the exhibit, or which are caused in whole or part by Exhibitor's products or Exhibit or by Exhibitor, his/her family, officers, agents, employees, or other representatives. UAPRN facilitates the Exhibition for the benefit of its attendees who support the annual conference. In so doing, it is imperative that Exhibition remain free of harassment of participants or other Exhibitors. Therefore, UAPRN expressly reserves the right to remove any Exhibitor in whole or in part, for any reason and with or without giving cause. If UAPRN removes said Exhibitor, Exhibitor shall not be refunded its Exhibition fee and shall release UAPRN from any and all claims related to Exhibitor's presence in the Exhibition Hall, including but not limited to lost profits or incidental travel or equipment costs at the Exhibition venue. Exhibitor is expressly prohibited from transferring this Agreement to a third party without written consent of UAPRN. UAPRN reserves the right to terminate this Agreement if we discover information, which demonstrates that the proposed Exhibition would be inconsistent with the principles espoused by UAPRN, unfavorable to the public reputation, or not beneficial to or for the attendees of the UAPRN annual conference. In this event, UAPRN shall refund any exhibit fees paid. The parties agree that the Exhibitor will not be refunded any additional expenses related to the Exhibitor's attendance at the Exhibition, including but not limited to lost profits, travel to the Exhibition venue, or other equipment or incidental costs. If the Exhibitor refuses or fails to comply with the terms in this Agreement, UAPRN shall treat Exhibitor's action as a cancellation and shall apply the terms outlined above.

It is the responsibility of the individual exhibitor doing business and making taxable sales during UAPRN's annual conference to abide by local and state sales tax rules.

UAPRN does not warrant, represent, or endorse any Exhibitor's goods or services to its members. Exhibitors must receive written approval from UAPRN before using NPA's logo or other trademark representation on Exhibitor's marketing materials. Exhibitor grants UAPRN and its agents, assignees, and employees' permission to take photographs of the Exhibitor in connection with UAPRNs marketing material and permits reproduction of same without prior subsequent notice provided to Exhibitor.

The exhibitor agrees to indemnify, defend, and hold harmless UAPRN, its members, officers, agents and representatives for any personal injuries, property loss or damage suffered by any person as a result of the actions or inactions of the Exhibitor. Further UAPRN shall not be held liable for their failure to perform or fulfill their contractual obligation provided such failure is caused, occasioned or furthered by closures of site locations due to any cause or causes by their control, including but not limited to acts of God, fire, flood, war, public disaster, strikes or labor difficulty, governmental enactment, or any other cause or causes beyond its control.

It is mutually agreed that no amendments, alterations, or variations of this agreement shall be valid unless made in writing and signed by both parties. This Agreement shall be governed by, construed, and enforced in accordance with the laws of the state of Georgia.

Set-up: Exhibitors will be allowed to set up their display booths on Thursday, September 18 after 5:00 pm or Friday, September 19 between 8:00 am - 10:00 am.

Exhibit Hours: Friday, September 19 from 10:45 am – 4:15 pm and Saturday, September 20 from 10:45 am – 2:15 pm. Exhibit Breakdown: All exhibitors can begin to breakdown their booths after the conclusion of the 12 pm on Sunday, September, 21st.

Cancellation: Cancellations will be subject to a \$100 administrative fee if the written request is received on or before August 1, 2025. After August 1, 2025, no refunds will be issued for cancellations for any reason or for no shows. If UAPRN cancels the exhibition, Exhibitor will receive a full refund of their exhibit fee. Product Description: On the application, the Exhibitor shall provide a description of the products and/or services that will be displayed and/or sold at their booth.
