## Meet Judy Leach, the First CNP in Arkansas

From the time she was a little girl. Judy Leach knew she wanted to be a nurse-it was her calling. She began her journey at Arkansas State University, graduating with an associate degree in nursing in 1973, before the university offered a BSN program. After gaining experience in a local hospital and a physician's office, she found her niche as a public health nurse with the Arkansas Department of Health (ADH) in Clay and Greene Counties. In 1978, the ADH supported Ms. Leach in completing a training program at the University of Arkansas for Medical Sciences. She became a Registered Nurse Practitioner (RNP) in 1979 after intensive coursework and a preceptorship, prepared her for national certification as a family nurse practitioner. Returning to Northeast Arkansas, she worked with the ADH Maternal Infant Child Health Program, providing antenatal care and family planning services through county health units. Her career continued to grow. In 1993, Ms. Leach accepted an RNP position at Paragould Doctors Clinic, serving Paragould and her hometown of Rector. When her longtime collaborating physician, Dr. Len Kemp, established Paragould Family Care, she moved with him to the new practice. In addition to her clinical work, Ms. Leach played an important role in shaping advanced nursing practice in Arkansas. While serving on the Arkansas State Board of Nursing in 1995, she helped draft rules implementing Act 409, creating the Advanced Practice Nurse license. Having completed graduate-level coursework in advanced pathophysiology, pharmacology, and health assessment, as well as holding national FNP certification, she was the first nurse granted licensure as a Certified Nurse Practitioner (CNP).

Reflecting on that transition, Ms. Leach notes that while the role of RNPs was defined by strict treatment protocols and physician oversight, becoming a CNP allowed greater autonomy and flexibility. CNPs could decide on and write the prescription, making care more efficient and convenient for patients, and enabling CNPs to provide truly individualized, evidence-based care.



After nearly five decades of service, Ms. Leach retired in 2021. Some of her fondest memories come from practicing in Rector, where she made house calls and cared for neighbors, friends, and families she had known all her life. She found deep fulfillment in identifying health problems, developing management plans, and working with patients and their families to meet their healthcare needs. Of course, with that responsibility came the natural stresses, wondering if she had missed something or should have done something differently, but overall, she treasures her years of hands-on practice, providing healthcare for her community. Her advice to today's generation of CNPs is simple but powerful: never stop learning. While she did not pursue advanced degrees, Ms. Leach completed countless hours of continuing education and emphasizes that healthcare is always evolving. No nurse can know everything, she says, and the most important thing is to practice confidently within your area of expertise and to acknowledge when you need to consult with other providers. I was honored to interview Ms. Leach and thank her personally for her service. Her career has left a lasting impact on the people of Clay and Greene Counties, and her legacy inspires nurse practitioners across Arkansas. Leonie DeClerk

# Tackling the Opioid Crisis: Pine Bluff Conference

The Arkansas Nurse Practitioner Association (ANPA) was proud to welcome nearly 100 participants to Tackling the Opioid Crisis in Rural Arkansas: Continuing the Conversation in Pine Bluff on September 26.

Arkansas has the highest per capita opioid prescribing rates in the nation. The misuse of prescription opioids—as well as the use of fentanyl, methamphetamines, and other substances for nonmedical purposes—remains a serious challenge across our communities. Nurse practitioners are well-positioned to lead efforts in addressing this ongoing public health crisis.

This program was made possible through a generous grant from Arkansas Attorney General Tim Griffin. Attendees included APRNs, nurses, pharmacists, students, and community stakeholders from across the state who gathered to hear an outstanding lineup of speakers.

Morning sessions featured presentations from Brian Parks, PhD, on the science behind substance use disorder; Arkansas Prescription Drug Monitoring Program Director Jamie Turpin, PharmD; Arkansas Drug Director Tom Fisher; Arkansas Opioid Recovery Partnership Director Kirk Lane and Deputy Director Tenesha Barnes, who discussed their statewide initiatives; and Elizabeth Riley, DNP, APRN, who shared insights from her naloxone training program. The afternoon featured a powerful panel discussion featuring individuals personally impacted by the opioid crisis—a highlight that deeply resonated with participants.

Feedback from attendees was overwhelmingly positive. One pharmacist noted that the conference "radically informed and changed the hearts and minds of all of us in that room." ANPA remains committed to promoting and advocating for excellence in practice. Stay tuned for more opioid education opportunities.
