## SEXUAL ASSAULT EXAMINER TRAININGS

Are you a healthcare provider serving American Indians/Alaska Natives? Do you want to become a Sexual Assault Examiner? Have you been struggling to find the time or funding to attend training? Now, you can access the same quality training online.

Beginning April 25, the Tribal Forensic Healthcare Training Project will offer a FREE 8-week online course open to registered nurses, advanced practice nurses, physicians, and physician assistants from IHS, Tribal, and Urban Indian health care facilities. Healthcare providers from other facilities that regularly serve American Indian or Alaska Native victims of sexual assault are also eligible to attend.

Participants will learn the elements of conducting comprehensive adult/adolescent medical forensic examinations in cases involving sexual assault. This 8-week (40 hour) web-based course will cover topics including:

- Trauma Informed Care
- Dynamics of Adult/Adolescent Sexual Assault
- The Medical Forensic Evaluation
- Medical Management
- Program/Operational Issues
- The Justice System and Testimony

### Eligibility

- 1. Participants must be US-based and licensed and in good standing as one of the following:
  - Registered Nurse
  - Advanced Practice Registered Nurse
  - Physician Assistant
  - Physician
- 2. This is a web-based course, offered entirely online. Participants must have regular access to an internet connection faster than analog/dial-up.
- 3. Participants must be able to commit a minimum of 5 hours per week to coursework, so that all coursework is complete by June 25, 2014.

#### Not Eligible

Providers who are currently practicing SAEs/SANEs and/or those who have already achieved SANE-A certification are **not eligible** to participate. This training is intended for those professionals looking to gain initial SAE Training.
