 - o also spoke with people at the Federal Trade Commission → supportive of APRN practice → "one profession should not regulate another profession"

APRN Alliance Report to the Board of Nursing April 2, 2014

Since the last BON meeting the Alliance has held three regular business meetings

- February 18, 2014
- March 1, 2014
- March 29, 2014

Minutes of those meetings are attached for your review and information.

Several members of the Alliance attended the AaNA Legislative Fly-in to Juneau on February 19, 2014. It was a productive trip. We took the opportunity to educate legislators about APRNs and our plan to introduce legislation next year. We also shared our support for SB 166.

We collected information from other states whose BONs have APRN advisory committees. Based on that information, and discussion at our March 1, 2014 meeting, we have decided not to include advisory committee language in our proposed statute changes.

Our statutory priorities are:

- Updating the definition of Advanced Nurse Practitioner and
- Title protection for APRNs

Other legislation we are watching is SB 80 "An Act relating to the practice of telemedicine; relating to prescription of drugs by a physician without a physical examination; and relating to insurance coverage for telemedicine." SB 80 defines telemedicine as "...the remote practice of medicine as a result of transmission of individual patient data by electronic, telephonic, or other means to a physician or the physician's agent." We are concerned that this could limit APRNs ability to participate in, and get reimbursed for, telemedicine activities. We are interested in ongoing, strategic discussions with the Board about this issue.

A copy of our statute working document is attached. This document includes APRN definition language and APRN title protection language on which the Alliance has reached consensus agreement. It also includes issues from SB 80 that we want to keep in mind as we move forward.

Thank you for your interest and participation in the APRN Alliance and for this opportunity to share our activity and progress.
