12. Describe and intervene in any side effects, adverse effects, precautions and monitoring of Pharmacological interventions.
13. Identify at risk populations.
14. Be able to treat uncomplicated HCV patients.
15. Know who to refer to specialist.
16. Identify CAP patients most likely to benefit from steroids.
17. Determine the optimal duration of antibiotics for CAP.
18. Evaluate the need for antibiotics in patients with a viral infection.
